Christopher Luxon on 9th day of December 2024 was declared insolvent due to non-payment of its debts with final day for payment being 17th day of December 2024 where the Crown of Her Majesty Queen Janine assumes Creditor's Rights has affirmed in the Royal Court of New Zealand for the restoration of God's Kingdom here on earth within the realms of the United Kingdom of New Zealand that no payment was received with public gazetting occurring on 9 December 2024 on publicnoticesnz.com plus formally notifying Christopher Luxon on tenth day of December also received by signature required courier post on twelfth day of December 2024 with the money outstanding at that time and amount due by the seventeenth of December 2024.

The 17th day of December 2024 was the final day for payment. The payment due on the seventeenth of December in the year two thousand and twenty-four was **two hundred and forty-two quadrillion, seven hundred and seventy-one trillion, eight hundred and forty-four billion, eight hundred and ninety-six million, four hundred and eighty-five thousand dollars in numbers \$242,771,844,896,485,000.00 to be paid out in 0.9999 gold bullion in ten once bars.
