Royal Court Insolvency Summary Hearing Dated 17th day of January 2025

This court hearing and all its content have been entered into the public records. Court recording commenced at 4.04pm on 17th day of January in the year of 2025.

From the word of Holy Word of God it states in Matthew Chapter 18 v16 and 20 "A matter shall be established by two or three witnesses." The three witnesses attending agree to act in this capacity and gave their first names as Margaret, Fred and Beverley-Jane.

The CEOs of the Crown and Council Corporations from the hearings dated 18 December 2024 and 3 January 2025 had until the seventeenth day of January 4pm in the year of 2025 to submit a report back to the Royal Assignor showing every register public and private and crown and admiralty plus any overseas register plus any other register that contained information regarding the corporation's financial operations with personal commercial liability for the debts owing and criminal liability for not providing this information.

Further Crown corporations were also found in the investigative process of discovery that are added to the insolvency list today due to either being the major shareholder of a crown corporation already liquidated or being a subsidiary crown corporation of a corporation already liquidated. The insolvencies and insolvency notices have all been publicly gazetted on publicnoticesnz.com as well as emailed and served to the head controlling office and officers.

The debt that all corporations and officers except two corporations became liable for is for the amount owing over the government crown corporations of two hundred and forty-two quadrillion, seven hundred and seventy-one trillion, eight hundred and forty-four billion, eight hundred and ninety-six million, four hundred and eighty-five thousand dollars in numbers \$242,771,844,896,485,000.00. The remaining two corporations are Ministry of Business Innovation and Employment and the Companies Office where their current debt sits at 130.337 septillion new zealand dollars (\$130,337,141,777,400,000,000,000,000.00NZ) and now that through discovery there is international is converted into US dollars which is 72.988 septillion united states dollars (\$72,988,799,395,200,000,000,000,000.00usd)

I, Janine Commander and chief and Royal Crown confirm that not one minister or chief executive officer or director or corporative representative or officer provided the financial operation records therefore due to personal liability all of the following chief executive officers and ministers and officers have been made insolvent payment with proof of debts and official document before the court for each corporation and individual. All the names and insolvency numbers were read out aloud and entered into the record that at 4.10pm the time the reading of the names of each of the following corporations and individuals were liquidated.

The following ministers and officers are declared insolvent and are no longer able to hold office and are lawfully removed to be replaced by the Royal assignor which is Royal Crown-Janine who will inform who the appointed Statutory manager is and until that time all insolvent officers and ministers are to report to her.

CEO stands for Chief Executive Officer, CE stands for chief executive in short for chief executive officer

Ministry of also refers to the Office of Ministry of

Crown-Janine UFN stands for Crown-Janine steps in until further notice as Royal Assignor and Statutory manager

If the names of the ministers or officered entered are correct as they are recorded on the websites of each corporation it is also considered that if his/her legal name is different that the legal name has also been entered into the record.

If the corporation or companies' website have not updated who the current chief executive officer or minister is, then it is considered that the appointment of his/her office is still taken over by the Royal assignor.

If there are any honest incorrect spelling errors of individuals or corporations the right is reserved to correct these names and it is considered that the correct registered names are entered into the record. If the word 'the' or 'of' or 'for' or any other minor word in a name or title is missing it is considered added correctly. If the word 'Limited' is missing it is considered entered however it does not limit liability on behalf of the corporations. The LOCAL AUTHORITY SHARED SERVICES also known as LASS offices are entered in their entirety where the companies' office register has removed their exact names, so all considered entered. A word is also considered correct regardless of macrons or letter accents.

These Summary Judgements are issued pursuant to Section 289 and 239 of the Companies Act 1993 and Insolvency Act 2006 of failure to pay the outstanding debt due and owing in due course a charge over the whole of the assets, liabilities and rights in the Crown of Her Majesty Queen Janine assumes Creditor's Rights and has affirmed in the Royal Court of New Zealand for the restoration of God's Kingdom here on earth within the realms of the United Kingdom of New Zealand assents to the place of Royal Assignor and Royal Assignee in the Crown of Her Majesty Queen Janine of the Royal House of Walters to administrate the liquidation of all of the corporations and officers named above.

A correction from an error in the hearing from tenth day of January 2025 where the insolvency number allocated of 100125507 for the Office of the Minister of Finance is now replaced with the new allocated number of 170125442 where the Royal Assignor Crown-Janine assigns the role of the Office of Minister of Finance back to her as the Royal Assignor and Statutory Manager.

The officers that were appointed at the Royal Court Hearing on the tenth day of January 2025 as Statutory managers to replace the officers stood down are: His Majesty King Nelson to step into the office of The Crown in Right of New Zealand and office of Parliament incorporated and His Majesty King Steven The Crown in Right of Australia to step into the office of Minister for Arts, Culture and Heritage and Dennis of the House of Mirosevich as director of Orbit Futures to step into the Office of Minister of Finance and Fred of the Royal House of Stewart to step into the office of Crown Law, and office of ministry of Maori Affairs. It is recorded here that due to non contact with the Statutory Managers during the first week of insolvency that the Office of the Minister of Finance and Office of Minister for Arts, Culture and Heritage have returned back to the Royal Assignor Crown-Janine as the Statutory Manager on the seventeenth day of January 2025, but further roles will be considered once clear lines of communication established with Dennis of the House of Mirosevich and His Majesty King Steven The Crown in Right of Australia.

All men and women in the private have a right to appeal the court decision and be formally trialed in front of their peers with the knowledge that if trialed in front of peers in the Royal Court under the Jurisdiction of God Almighty that the charges already in place commercially due to evidence of harm and loss will lead to criminal charges of harm. If the man or woman shows remorse to their actions or decisions or lack of actions then he or she will have the opportunity to communicate their commitment to help undo harm, and victims will have the opportunity to declare his/her victim impact and the court will decide on the appropriate sentencing. Following orders is not an acceptable reason for an appeal for all are accountable for his or her own actions.

As all the officers are now declared insolvent and now entered into liquidation and statutory management all of their roles as minister, director or chief executive officer have now become vacant, where the Royal Assignor Crown-Janine steps in to fill this role until the Royal assignor appoints someone else into this role. In law the ministers and officers made insolvent are not able to hold

positions of authority, so the Royal Court makes it clear that these ministers and chief executive officers can not be appointed into any other roles or portfolios and any decision he or she makes from the time of insolvency is unlawful and is considered revoked unless the Royal assignor or appointed Statutory manager approves that decision in writing.

Royal Crown-Janine will appoint men and women to take over as Statutory Managers over the next few weeks, where she will remain in the role of Royal assignor in the Kingdom of God as representing Almighty God and all the inhabitants of earth as trust protector where she is to ensure that all appointed statutory managers at all times act in the best interests of the crown beneficiaries where the statutory managers are required to be fully accountable to her and can be removed at any time if it is determined that they have stopped acting in the best interests of the inhabitants with Royal Crown-Janine having royal rights to appoint in position and remove from position the Assignees and Statutory Managers as identified or any others that are appointed at a later date.
