Notice of Claim on Land of Substance

This document and its attachments are presented with honourable and peaceful intent and are expressly for your benefit to provide you with due process and a good faith opportunity to state a verified rebuttal to this claim.

From:

Living man 'David Russell' of the family/tribe of Jones, *sui juris*, hereby claiming all rights *nunc pro tunc*.

As of this date known as *thirtieth June Two thousand and twenty-three*
I do hereby claim and declare that the Lands of Substance previously known as 10 Gunga Lane, Lower Kaimai, Tauranga (see attachment A) and now known as 'Joneseez Place' are to be henceforth considered as held in Allodium, land not held of any lord or superior, in which therefore the owner has an absolute property right and not a mere estate.

I, living man 'David Russell' now claim and hold supreme authority over all lands as identified on attached Map A, and all resources living or otherwise, using Natural law, God's Law holding supreme jurisdiction in allodium; land freely held and occupied without obligation of service or fee to any overlord or landlord or government or local government.

The allodial designation over this physical land is established through careful observation and consideration of the following facts:

- 1 I, living man 'David Russell' am a living, breathing being and not a dead fictitious entity; and
- 2 I, as a living man have supreme authority over any corporate entity; and
- 3 The land I am living on is not artificial as it has physical substance; and
