On the 1st day of November you received the Notice of Affidavit of Status of Janine Barbara and Claim on Land of Substance known as 37A and 37B Glue Pot Road Oropi and Trespass Notice. The postal receipt showed the document was received at 8.38am on first day of November 2023 with twenty one [21] calendar days from time of receipt to rebut the affidavit point by point and send back to me with your wet ink signature in your full private and commercial capacity, with failure to do so accepted as tacit acceptance and silent acquiescence that this claim and its contents in its entirety, including exhibits stands as fact and truth in commerce and judgement in Law. The final time for rebuttal was 8.38am on Wednesday 22nd of November 2023. No rebuttal was received, and this has now been placed on public notice website publicnoticesnz.com.

Thank you for your silent acquiescence and tacit acceptance of the Affidavit now standing as truth in its entirety in law and commerce.

The affidavit included charges to you for \$90,000 and \$2,000,000 which now are my right to lawfully claim. Enclosed with this letter you will find the final third demand invoice notice for payment for two million and ninety thousand dollars [\$2,090,000.00] dated 22nd of November 2023 with ten working days to make payment into the bank account on the invoice and also included here. You probably have liability insurance to cover this compensation charge. The bank account name is House of Talia Dawn Private Foundation with bank account number of 38 9024 0122732 00. In the event of non payment I have the lawful right to seize and liquidate your assets and claim accruing interest until payment is received and claim for all associated costs. These actions were taken due to you acting in dishonour where you were even given two opportunities to have these charges dropped. As your actions occurred in your capacity as Chief Executive Officer of the Western Bay of Plenty District Council I also have the lawful right in event of non payment to seize assets belong to the WBOP District Council corporation.
