- 1. Statement of Undefended Claim of Commercial Lien by Force of International Admiralty and Common Law for payment of one hundred and eighty two million four hundred and eighty one thousand four hundred and thirty eight new zealand dollars (\$182,481,438.00NZ) by five pm on twentieth day of March 2024 or the lawful right to liquidate the corporation and its assets until paid in full. The breakdown of this figure is one hundred and fifty million dollar charge of harm caused to claimant from multiple actions of harm plus charges for loss of livelihood with penalties added adding extra \$32,481,438.00. All charges were clearly identified in claimants compensation schedule and liability notice including dates and which of the debtors were involved. The evidence provided also has criminal implications which will be the next stage in event of non payment.
- The commercial charges in summary are for actions of harm and fraud and cover up related to harm towards the claimant with loss of livelihood and health and safety jeopardised from May 6 2021 until time of termination from livelihood on December 21st 2021.
- 3. Death of the Claimant's daughter on 18 March 2021 while under the formal care of the officers of the corporation with failure of duty of care, plus covers ups of actions/neglect of officers to prevent liability.
- 4. Harm to the claimant caused by mandates and implementing the traffic light system 2 December 2021 excluding herself and other staff from working plus from using the health services, breaching of universal declaration of rights plus unalienable right of every man and woman.
- 5. The heads of the ministry of Health and Chief Executive officers of District Health Boards (who are named Defendants in this filing) in November 2021 releasing of false information to the public declaring the covid 19 vaccine was safe and effective, where they were informed by the Claimant that this information was false before it was released to the public making them liable for any severe adverse reaction or death that resulted after taking the covid-19 vaccine.
- 6. In November 15 2021 the Chief Executive Officers of the District Health Boards mandated and co-erced employees including the claimant (who identified herself as a living sentient being where jurisdiction of the Crown corporation removed) to take the covid-19 vaccine where evidence was presented by the claimant prior that one of the risk factors is death which is an absolute breach of the universal rights plus Nuremberg principles plus Unalienable rights, where the Chief executive and

the

- management staff who were involved in terminating employment have liability for breaching this right.
- 7. Notice of Liability was sent first time via email on 25 November 2021 to Peter Chandler, Don Sorrenson, Scott Hart plus others for failure to provide a safe place for Claimant to work plus failure of duty of care of DHB staff towards Claimant's daughter who died under the care of the District Health Board. The Liability Notice was served multiple times to all Debtors with no rebuttal and remained a live document with all postal tracking receipts and references included with this claim.
- 8. Evidence has also been provided with up to date facts and data from February and March 2024 that there are currently seventy four thousand three hundred and thirty (74,330) people living in New Zealand having severe adverse events following taking the covid -19 vaccine, evidence provided of thirty two (32) verified deaths related to taking the covid-19 vaccine, evidence provided of at least four thousand (4000) unexplained excess of deaths in New Zealand since the covid-19 vaccine roll out.
- Loss of employment and livelihood of the claimant, psychological harm caused to the claimant plus loss of her daughter, failure to address her health and safety needing and terminating her employment and livelihood instead.
- 10. The public informed via the news media on 13th day of October 2023 that the District Health Boards exempted 11,000 employees from taking the covid-19 vaccine showing discrimination towards others including the claimant who wasn't exempted even though she was an essential health worker and could do all aspects of job with 2m social distancing showing evidence of breaching unalienable and universal rights.
- 11. The claimant informing the Chief Executive Officer firstly on third of November 2021 that the drug Remdesivir and its generic equivalent was causing excess death where the corporations and Chief Executive Officers and other Officers and Debtors were provided the research evidence that this drug was causing excess deaths and continuing to use this drug causing ongoing excess deaths, with failure of duty of care towards the Claimant Janine and her daughter Talia and the staff working for the organisation and the people of New Zealand of Bay of Plenty District Health Board and all District Health Boards all now known as Health New Zealand and Te Whatu Ora. The specific date of events and which debtor involved in each event with time place and person is in the liability notice and affidavit. The lien debtors have also been advised of the specific charges related to all events with a further eighty billion dollars to be added in the event of non payment by 20th day of March 2024 where the claimant is adding charges for every man woman or child that has had a severe reverse reaction or died from being co-erced or lied to. The claimant has provided evidence of her compensation schedule of one-million-dollar charge of for any harm to any man, woman and child in her land being the land of New Zealand.
- 12. Evidence presented dated 11th day of November 2021 of fraudulent writing of deaths down as covid-19 to try and raise the number of deaths from covid as a 'marketing tool' to promote the vaccine where the individual officers have liability for this.
- Full explanation and details of the Claim is in the attached Commercial Lien by Force Document plus all supporting documents in the Sequence of Events from April 2013 to March 2024


