The Plaintiff Informs The Court Registrar and the Debtors of the Following

- 1. The appointed legal representative Chris Jury of Health New Zealand and the defendant requested the high court Admiralty Statement of Claim with all supporting documents to be received by email for serving of all documents. The documents were received by first receipt by email to chris.jury@tewhatuora.govt.nz on 18 March 2024 with the hard copy received by courier post on Tuesday 19 March 2024 at 6.30am, and first receipt of Memorandum One being 25 March 2024 and first day of receipt of Memorandum Two being fourth day of April 2024 with last day for defence being 5pm on Thursday the eighteenth day of April 2024. The legal responsibility to inform all debtors and defendants is on Chris Jury. (see high court rule 5.43)
- 2. The Memorandum Two of Plaintiff on Summary Judgement of Admiralty Claim dated 4 April contained Affidavit of Service for five defendants.
