- (f) any claim for loss of life or personal injury sustained in consequence of any defect in a ship or in her apparel or equipment, or of the wrongful act, neglect, or default of the owners, charterers, or persons in possession or control of a ship or of the master or crew thereof or of any other person for whose wrongful acts, neglects, or defaults the owners, charterers, or persons in possession or control of a ship are responsible, being an act, neglect, or default in the navigation or management of the ship, in the loading, carriage, or discharge of goods on, in, or from the ship or in the embarkation, carriage, or disembarkation of persons on, in, or from the ship:

<u>Vessel</u> – a type of watercraft including artificial capable of being used as carrying or transportation of personal property for hire for purposes of commerce (includes a person)

In the matter of

- Statement of Claim of Commercial Lien by Force of International Admiralty and Common Law for payment of three billion and three million dollars (\$3,003,000,000.00NZ) with ten percent interest added per week from ninth day of March in year of 2024. All charges were clearly identified in claimant's affidavit and compensation schedule and every document sent with proof of receipt of every document outlined in the sequence of events.
- 2. The initial charge was for three million five hundred and thirty eight thousand and seventy dollars (\$3,538,074.00) as the amount the claimant had calculated that she was aware that the ASB had fraudulently taken from her, but had formally requested Vittoria Shortt to confirm how much they had taken out of her estate with the high likelihood of the amount being higher and in event of non payment and no response that as the Secured Party Creditor for three billion dollars that Janine could claim the higher amount of three billion dollars. Vittoria Shortt as the Chief Executive Officer and formal representative of the ASB Bank was also informed that any withdrawals of money taken by the ASB bank from 1 December 2023 would invoke a one million dollar compensation fee charge and so far as of 21 March 2024 the ASB bank has done this four times. There were three charges at the time of the commercial lien and one further one million dollar charge has occurred since then.
- 3. Vittoria Shortt has had every opportunity to rebut or remedy the claimant's charges and has acted in dishonour and bad faith and has not provided full disclosure with the claimant having lawful right for summary judgement for the amount of claim for three billion and three million dollars plus one million dollars charge for all further events of taking money out of the claimant's authorised bank accounts plus penalty interest of 10% per week from the ninth day of March 2024. Vittoria Shortt on behalf of ASB Bank has made no rebuttal and no defence where an unrebutted Affidavit stands as truth in law and commerce according to the ten Commerce Maxims in law.
- 4. That the Claimant Janine has gone through a full lawful process and claimed back complete Power of Attorney to manage and administer all her affairs and estate and property having revoked all previous power of attorneys and is now the Secured Party Creditor.
- That the Claimant Janine has had three witnesses overseeing, observing, affirming and certifying all notices sent to the Debtors where two Corinthians chapters thirteen

verse one declares that from the mouth of two or three witnesses that every word is established as truth.

- That a foreclosure by a summary judgement (non-jury) without a commercial bond is a violation of commercial law. An official (officer of the court, policeman, etc.) must demonstrate that he/she is individually bonded in order to use a summary process.
- 7. That an official who impairs, debauches, voids or abridges an obligation of contract or the effect of a Commercial Lien without proper cause becomes a lien debtor, and his/her property becomes forfeited as a pledge to secure the lien.
- Full explanation and details of the Claim is in the attached Commercial Lien by Force
 Document plus all supporting documents in the Sequence of Events from April 2013
 to March 2024.
- In commerce, it is a felony for the Officer of a Political Party/Public Office/Banking Corporation to not receive and report a Claim to its Bonding Company – and it is a felony for the agent of a Bonding Company to not pay the Claim.
