The charges are failure to provide a safe place for the Claimant Janine to work then terminating her employment, plus failure of duty of care of DHB staff towards Claimant Janine's daughter who died under the care of the District Health Board who are now known as Health New Zealand, plus failure of duty of care towards co-ercing staff and the people in land known as the colony of New Zealand to take an experimental vaccine with evidence that one of risk factors is death and failure to record severe adverse events and deaths and failure to offer other treatment protocol removing people's rights to choose and loss of livelihood through mandates with liability for all harm caused. That Diana Sarfati in private and representing MINISTRY OF HEALTH was also provided the opportunity to rebut the statement that was backed up with evidence in the Admiralty Statement of claim against HEALTH NEW ZEALAND that the Ministry of Health released a statement to the public on 21 November 2021 that the covid vaccine that they were requiring all New Zealanders to take was not effective, that it does not prevent transmission, plus at this time the first covid vaccine death had been documented on an autopsy report that the officers in the Ministry of Health and Health New Zealand (previously known as District Health Boards) knew that the vaccine was neither 'Safe' or 'Effective' but continued to promote this message to try and co-erce all New Zealanders to have the vaccine, where one of the risk factors is death. As the officers within the MINISTRY OF HEALTH had knowledge that the covid vaccine was neither safe or effective then they had no lawful right to enforce the people of New Zealand to take the vaccine where one of the risk factors is death and the corporation and it's officers are therefore liable for loss of employment and licenses plus any severe adverse reaction to taking the covid vaccine plus loss of life, and in the event of non-rebuttal it is taken as tacit acceptance and silent acquiescence that he/she is fully aware that this has occurred and has done nothing to stop it, and therefore holds full accountability and commercial liability where there is a one million dollar compensation fee for any harm caused to any man, woman, boy or girl living in the land of New Zealand

That Janine as Commander over all the debtor corporations and their officers with immediate effect restores the rights of every individual living in the land known as the colony of New Zealand are fully restored with immediate effects of the inalienable rights of all men women, boys and girls being the right to freedom, equality and dignity, no discrimination, right to life, liberty and security, right to not be held in slavery or any form of torture or degrading treatment or punishment, right to be treated fairly, no unfair detainment, innocent until proven guilty, the right to privacy, the right to freedom of

These rights can not be taken away, includes the right to make informed decisions around one's own health and wellbeing, and also includes freedom of speech in mainstream media and social media with censorship being unlawful and a chargeable offence unless there is proof of a crime of violence or harm.

- 9. That Diana Sarfati and Chris Luxon and Shane Reti and Lester Levy were instructed as individuals and representatives of the listed Debtor corporations by 19 September 2024 to release in the media that the covid-19 mandates are fully removed due to my unrebutted High Court evidence provided at the time of the Mandates that the vaccines were neither safe or effective and all licenses and jobs reinstated with immediate effect to help solve the health crisis of insufficient clinicians to provide health services. They were also instructed to state in the media that the inalienable rights have been restored back of every man and woman to have full disclosure of information and the right to choose for their own health and wellbeing. That Big Pharma are required to inform the public of the full ingredient list in cancer drugs and all other drugs the profit mark up and the success rate of each drug where all alternative treatment options be released with the same information that men and women can make informed choices and choose what is best for them. The same information is also required to be released to the public for every vaccine for full disclosure of contents in each vaccine and if MRNA has been added to other vaccines as well as covid vaccines, the profit margin markup and full research and statistics to the safety and effectiveness. Decisions around health and wellbeing will now be health driven by individual men and women not big pharma or corporation profit driven or control. As these instructions were not followed Diana Sarfati and Chris Luxon and Shane Reti and Lester Levy are not only facing commercial liability for harm towards individuals but also criminal charges and crimes against humanity charges where they will now be brought before a world court.
- 10. That Janine as Commander over all the debtor corporations and their officers is the new lawful and legal owner has the right to seize and take control over all assets and the officers and workers or contractors within the corporation must obey orders given by her, and if anyone tries to obstruct her she has the lawful right to remove them and charge with obstruction of justice with a commercial charge of harm or for one million dollars per event and per man or woman effected.
