NOTICE Orders & Instructions for Immediate Action

To: All Officers, ministers, agents & employees and agents of all District and Regional Councils within Aotearoa, in the realm of New Zealand plus TAURANGA CIVIL HIGH COURT, HIGH COURT OF NEW ZEALAND, NEW ZEALAND HIGH COURT, HIGH COURT NZ, NZ HIGH COURT, MINISTRY OF JUSTICE, HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND, THE QUEEN'S MOST EXCELLENT MAJESTY IN RIGHT OF NEW ZEALAND, THE SOVEREIGN IN RIGHT OF NEW ZEALAND ACTING BY AND THROUGH THE SECRETARY OF FOREIGN AFFAIRS AND TRADE, MINISTRY OF FOREIGN AFFAIRS AND TRADE, RESERVE BANK OF NEW ZEALAND, INLAND REVENUE,INLAND REVENUE DEPARTMENT, LOCAL GOVERNMENT NEW ZEALAND, NEW ZEALAND LOCAL GOVERNMENT FUNDING AGENCY, NEW ZEALAND TREASURY, NEW ZEALAND DEBT MANAGEMENT, NEW ZEALAND POLICE, HEALTH NEW ZEALAND, MINISTRY OF HEALTH, WESTERN BAY OF PLENTY DISTRICT COUNCIL, ASB BANK, ASB HOLDINGS, and BOP LASS (hereafter known as 'all listed corporation and crown corporations').and their officers, ministers, judges, agents & employees; plus all banks operating within the realm of New Zealand including parent corporations and ultimate Holding Corporations;



To all to whom these presents shall come:

All listed and crown corporations are informed that I, Janine the House of Arabella, took over as Commander and Chief over all listed and crown corporations from Friday the 19th day in the month of July in the year of 2024, with further takeovers on 20th day in the month of August 2024 with full control and ownership/guardianship over all the assets of all listed and crown corporations in place by 20th day of the month of September 2024. The takeover dates of each corporation are listed in paragraph 24. All of the assets are now held in Janine's Trust of which I Janine of the House of Arabella am the co-settlor where all the people of New Zealand are the beneficiaries.

Whereas, due to the lawful process we have gone through, unrebutted acquiescence, tacit admission, on behalf of Almighty God and on behalf of all men, women, boy and girls, living in and on our lands, all listed and crown corporations were taken over due to fraud and deceit, and being in dishonour of payment of the lawfully placed commercial liens. As we have taken over the running of all listed and crown corporations that makes Crown Corporate Law, I Janine have the lawful right to add, alter, amend and delete any laws/orders made that are causing injustice and harm, and add laws/orders for protection of the people and the lands.

Orders from the day of Friday the 19th in the month of July in the year of 2024 can only come from the lawful Commander and Chief of each of the above crown corporations and as I, Janine shall now declare that any orders or decisions made after this date by all listed and crown corporation agents and officers, are null and void, unless there is written authorisation made by me, Janine. My orders are clear for all recipients of this communication and have attached to all listed and crown corporations the full orders that have gone out with a summary as stated herein; Therefore I, Janine of the House of Arabella, the Commander and Chief of all listed and crown corporations in Aotearoa, in the realm of New Zealand, have backdated the following orders from Friday the 19th day of the month July in the year 2024 and *shall* with full authority;

1. Declare that I have placed this country and these courts and the government of this country under the Jurisdiction of Almighty God with the Holy word of God from the Bible as the highest authority where Crown corporate laws shall become obsolete when any lies and deceit is found in any man made laws and contracts. I, Janine quote **Exodus chapter 20 verses 15 and 16** *"Thou shall not steal and though shall not bear false witness against thy neighbour."* The corporation and their officers shall now held liable for all actions of making the people debt slaves and placing on them a debt that was never theirs and for forcefully controlling the people by deceit. I Janine, quote Genesis Chapter one verse 27 *"so God created man and woman in his own image, the image of God he created them, male and female he created them."* God made men and women and men and women made corporations. A corp-oration (dead man speaking) can never have control over a man or woman;

2. Declare that I have issued an Immediate Cease and Desist from placing of any fluoride or other harmful chemicals or substances in any water supply within this land known as Aotearoa, in the realm of New Zealand into our water or onto our land or into our air or into our food supply or into our animals or plants or into vaccinations or other recommended pharmaceutical drugs, with a minimum one million dollar charge of harm on behalf of every man, woman, boy and girl in Aotearoa, New Zealand per event, where the government own data released on 31 March 2024 had the population at that time being 5,388,900 which brings the total amount of commercial liability for placing fluoride or any harmful chemicals or substances to five trillion, three hundred and thirty-eight billion, and nine hundred million dollars that will be released instantly to the people or the people of each council local government area can seize all the local assets and take over the running of their local communities in such a way that no harm is done, plus can take over immediately the personal assets of any agent, officer, minister or employee of any crown or council corporation continue with any actions of harm; 3. **Declare that I have** provided the means to pay off the National Debt on the 19th July 2024 and the officers did not comply with the order. So with full lawful rights and authority, from the 20th of September 2024 I actioned the cancellation of the national debt over every man, woman, boy and girl, as it was never their debt to begin with;

4. **Declare that I have** instructed the officers of the listed crown corporations to reduce all forms of personal & income & goods & services taxes to a maximum of ten percent by the 7th of October 2024 and the officers did not comply with the order. So with full lawful rights and authority, I have cancelled all personal & income & goods & service taxes that have been placed on the people due to all of these being charged fraudulently and these taxes can no longer be enforced with individual men and women having the right to charge an officer or agent who tries to enforce fraudulent & cancelled taxes upon them with all past taxes owed & student debts cancelled from 19 July 2024;

5. **Declare that** I had ordered that the crown corporations reduce property taxes/rates to a maximum of one thousand per year per property backdated to the 19th day of July in the year 2024 and the officers did not comply with the order. So with full lawful rights and authority, I have cancelled all property taxes and rates altogether due to fraud backdated to the 19th of July 2024 with any past charges or debt owed cancelled and unenforceable;

6. **Declare that** I have ordered that all listed and crown corporations can no longer enforce fuel taxes, road user charges, toll fees, or public parking fees on individual men and women. No officer or representative *shall* have the authority to impose or enforce these unlawful charges. Travelling on New Zealand roads and parking is now free to ensure the right to freedom of movement within and across the realm of New Zealand;

7. **Declare that** I have ordered that all fines related to speeding, parking, and property violations shall be immediately suspended, as such fines can only be imposed when a crime involving harm to another individual is proven. Consequently, only crimes involving harm *shall* be enforceable. This measure aims to prevent the unjust collection of revenue from the public. I also order that police officers *shall* be reestablished as 'peace men and women.' Additionally, local councils and courts in New Zealand shall shift their focus from revenue generation to serving the public and preventing harm;

8. **Declare that** I have abolished the legal system as applied to the people, as the original meaning of the term 'legal,' according to the 1893 Dictionary of Arts and Science and Encyclopaedia Britannica (1893 volume), is defined as *'the undoing of God's law'* or the removal of God. Henceforth, we are now under the jurisdiction of God Almighty and the laws of God, as revealed in the Holy Word. Furthermore, Crown law is corporate law, which only governs corporations, not individuals;

9. **Declare that** due to having exposed the deception within Crown property land titles, where individuals have been misled into believing they are purchasing actual property. In reality, they only possess a document title with geographical markings, while the land deed has been withheld from them. Wherever fraud is found on documents and titles they have become null and void and all crown property titles now revert back to the unextinguished native titles. To protect individuals who have innocently bought property believing their titles to be true and correct, they are assured that if they are living on a piece of land they retain the right to keep living on that land where individuals *shall* be shown the process shortly to claim full living rights to remain living on that lands;

10. **Declare that** as a result of Crown property land titles over lands becoming null and void then mortgages have become null and void due to fraud and deceit. That payment on mortgages can no longer be enforced, and banks and officers working within the banks can be charged for fraudulently continuing to remove funds from bank accounts including taking out fraudulent property taxes/rates. So with full lawful rights and authority, to perfect the law, I confirm that Crown property titles are now obsolete due to fraud, and the mortgage is attached only to the Crown title, and so now the Crown title is obsolete, and the mortgage is also obsolete. To make certain there is no misunderstanding. I repeat this a third and final time. Mortgage documents and Crown land title documents were created fraudulently and anywhere there is fraud the documents become null and void;

11. **Declare that** I have rendered mortgages void. Therefore if bank corporations continue to charge individuals for these now null and void mortgages, the affected individuals *shall* file claims of harm against the banks and their officers. If banks wish to continue their operations, they must demonstrate a commitment to acting honourably. They are no longer permitted to function as fraudulent debt collectors and will face charges for operating as fraudulent third-party debt collectors;

12. **Declare that** all my previous documents were created as living documents solely under the jurisdiction of Almighty God and His Holy Scripture. The case format, whether upper, lower, or title case, is irrelevant; what matters is the truth. Each individual of the crown corporations had the opportunity to rebut, and their failure to do so means that my documents stand as truth in law and commerce. Consequently, the commercial charges remain in effect and *shall* continue to increase by ten percent per week until fully settled, with the lawful right to impose additional charges for harm as the complete truth is revealed;

13. **Declare that** all assets belonging to the aforementioned corporations shall be placed in Janine's Trust, where I, Janine, am a co-settlor, and all individuals residing in the lands are the beneficiaries. These assets are for the use and benefit of the people. If any officer of a corporation or agent acting on behalf of any of the listed corporations attempts to misappropriate any of these assets, they *shall* be subject to theft charges, along with various other legal charges. The asset lists of these corporations are now considered public property, and the people have been notified that all corporate assets belong to them as beneficiaries. They can inform me of any unlawful sale notices or activities;

14. **Declare that** the original 1835 Declaration of Independence initiated between King George IV and Ariki Hongi Hika and the Treaty of Waitangi 1840 where the native translation is the true recognised version, where both continue to stand as truth that can not be denied, with the Mauri Native people having the lawful right to sovereignty and independence, free to assemble and operate without interference from the crown corporations or the New Zealand police force, enabling Rangatira and lawmakers to establish, organise, and assert all their rights, powers, privileges, and authorities as they see fit for their Nation; where no man or woman or boy or girl living in this land are subject to Crown Corporation Law, fully able to set up their own governance on the lands providing all men and women with the opportunity to choose.

15. Declare that I have issued an Immediate Cease and Desist on all agents and ministers of the listed corporations and crown corporations, as well as Te Tii Trust Board, Ratana, Waitangi Trust Board, Kingiitanga, Ngapuhi Iwi, Minister of Maori Development, Minister of Treaty of Waitangi Negotiations and any other current or successor signatories; are to cease signing the annual Waitangi contract on or around 6th February every year, to keep all listed corporations and crown corporations in power, knowing they are foreign entities registered in Washington D.C and the United Kingdom. Any monies or cheques that enter Aotearoa for the nation shall be given back to the Crown of the Mauri Native Nation (previously known as Maori) for the benefit of their people. Any individual found to be a signatory to this annual Waitangi contract or withholding the people's money shall be charged with full commercial liability in the private which will mean seizure and takeover of all personal assets; a minimum one million dollar charge of harm against any man, woman, boy or girl in Aotearoa New Zealand affected; and you will lose all lawful rights of claim of any land claims in Aotearoa New Zealand for any actions of harm against the Crown of the Mauri Native Nation, Rangatira, Lawmakers and their people;

16. **Declare that** I have arranged all my affairs, including the designation of a successor to take on my responsibilities in the event that something happens to me, or to act on my behalf if I am unable to be present to implement any orders. My successor *shall* also have an appointed individual to assume the role of Commander, ensuring that actions and orders can proceed without interruption until all actions and claims of harm are fully addressed;

17. **Declare that** a committee is established to address harm caused by the COVID-19 vaccine. This committee will allow individuals to file commercial claims for harm, including evidence of deaths, severe adverse reactions, discrimination, and loss of employment or livelihood. Claims submitted to the committee will be thoroughly verified for authenticity. All valid claims shall be compensated, or the individual can request their payout to be fulfilled through one of the Crown corporation's assets;

18. **Declare that** the rollout of all mandated vaccines, including those for children, the elderly, and flu vaccines, *shall* cease immediately until there is full disclosure regarding the contents of these medications, the rates of success and effectiveness of each drug, their profit margins, and all alternative health and treatment options, along with the same information. It is essential that individuals are not subjected to the control of Big Pharma companies over their health and wellbeing, with a minimum one million dollar charge of harm in place for any type of harm that happens to any man, woman boy or girl in Aotearoa New Zealand;

19. Declare that the current debt of all the listed corporations is \$24,892,991,374,021.20 Twentyfour trillion, eight hundred ninety-two billion, nine hundred ninety-one million, three hundred seventy-four thousand, twenty-one dollars and twenty cents any currency of my choosing or Pure Gold (Tender: 99.99% 1 troy once Pure Gold Legal Tender Minted Coins) due for immediate payment, into the housing fund or any account nominated by me, that I oversee as the living Commander, and if there is not an immediate payment we will exercise with full lawful rights and authority the liquidation of all assets belonging to its directors and any officers holding liability. ASB Bank and Crown corporations possess the bank account number for the deposit, known as the House of Talia Dawn Private Foundation, recorded on the Live True Bill Ledger which has Ten percent accruing interest per week until settled in full, and the lawful right to add further charges of harm, for minimum of one million dollars for every man, woman, boy and girl per event;

20. **Declare that** recently, Nicola Willis, in her capacity as Finance Minister, disclosed to the public the profit margins being generated by power and communication corporations, some of which are partially owned by the Crown. Therefore, I, Janine, as the living Commander overseeing the Crown corporations, order that the profit margins for Crown energy and communication providers *shall* be reduced to a maximum markup of 20% for monthly charges related to power, telephone, mobile, and internet services. This ensures that every household and individual can maintain essential communication with their loved ones, regardless of their location in the world. This directive shall establish a precedent for all other energy and communication providers;

21. **Declare that** to date, the media has been controlled by corporations based outside of our country. Therefore, as of the 8th October 2024, we hold accountable all individuals who disseminate false information with the intent to deceive and cause harm. These individuals, as well as the corporations they represent, can and *shall* be charged minimum one million dollars for every man, woman, boy or girl that has been affected. From this date forward, they are commissioned to convey the truth and refrain from causing harm, bearing full liability for the continued spread of false information;

22. **Declare that** any individual acting on behalf of a corporation who engages in actions that cause harm to our people, children, land, food, water, animals, plants, air, or any other essential resources for survival will be held accountable and charged. This includes those participating in euthanasia and abortion. Additionally, all ingredients in foods, medications, or products that enter our bodies, as well as chemicals sprayed on plants, must be listed. If any product fails to provide this information, it *shall* be removed from the market. Furthermore, any product containing harmful substances will also be removed from circulation;

23. **Declare that** pilots and the corporations they represent, who continue to spray known or unknown harmful substances into the atmosphere, *shall* face charges. Individuals will have the right to file lawful claims for harm under God's law. Additionally, aircraft operated by these corporations can be repurposed and given to the people for beneficial use rather than harmful activities;

24. **Declare that** any officers or agents representing a corporation who utilise technology to manipulate the weather or the earth in a harmful manner will face legal charges. The technology, devices, or products responsible for causing harm, along with the assets of these corporations, *shall* be seized by individuals filing lawful claims of harm under God's law;

25. **Declare that** for any other matters I may have overlooked, where an individual causes harm on behalf of a corporation, both the individual and the corporation *shall* be held accountable by the people through legitimate claims of harm under God's law. Furthermore, I stipulate that no officer of any corporation *shall* issue orders without my written authorisation. Any orders given without my approval are considered null and void. Additionally, I did not authorise the Crown corporations to affiliate our country with the United Nations; therefore, we maintain our independence and sovereignty;

26. **Declare with** full lawful clarity corporations HEALTH NEW ZEALAND, ASB BANK and ASB HOLDINGS were taken over on Friday the 19th day in the month of July in the year of 2024, and WESTERN BAY OF PLENTY DISTRICT COUNCIL and BOP LASS were taken over on the 20th day in the month of August 2024 and all other listed crown corporations TAURANGA CIVIL HIGH, COURT, HIGH COURT OF NEW ZEALAND, NEW ZEALAND HIGH COURT, HIGH COURT NZ, NZ HIGH COURT, MINISTRY OF JUSTICE, HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND, THE QUEEN'S MOST EXCELLENT MAJESTY IN RIGHT OF NEW ZEALAND, THE SOVEREIGN IN RIGHT OF NEW ZEALAND ACTING BY AND THROUGH THE SECRETARY OF FOREIGN AFFAIRS AND TRADE, MINISTRY OF FOREIGN AFFAIRS AND TRADE, RESERVE BANK OF NEW ZEALAND, INLAND REVENUE, INLAND REVENUE DEPARTMENT, LOCAL GOVERNMENT NEW ZEALAND, NEW ZEALAND DEBT MANAGEMENT, NEW ZEALAND POLICE and MINISTRY OF HEALTH were taken over with full control and ownership/guardianship over all the assets of all listed and crown corporations in place by 20th day of the month of September 2024. Further corporations will be taken over if harm continues and this includes all local, district and regional council corporations;

27. **Declare that** in matters involving inalienable rights of every man and woman, individuals are considered to be solely responsible for their actions and *"I was only doing my job",* quoted from Nuremberg principles *'acting on advice', 'acting under direction', 'acting under orders'* or any justification which involves a *'superior authority'* (such as an unsafe court decision) does not present as an acceptable defence, with a one million dollar charge of harm on behalf of every man, woman, boy and girl in Aotearoa, New Zealand per event;

28. **Declare that** you are informed that God Almighty has instructed me to call down the Holy Watchers revealed in Daniel Chapter 4 verse 17 who are watching the actions of all men and women and those who do harm from this time are invoking the judgement of God upon themselves;
