

PROCLAMATION of Janine of The House of Arabella and Walters on the Eighth day of October I the year of our Lord 2024 as the Commander of the Crown Corporations and all other listed corporations in this declaration.

1 John chapter 1 verse 5-10 says: This is the message we have heard from him and declare to you: God is light; in him there is no darkness at all. 6 If we claim to have fellowship with him and yet walk in the darkness, we lie and do not live out the truth. 7 But if we walk in the light, as he is in the light, we have fellowship with one another, and the blood of Jesus, his Son, purifies us from all sin. 8 If we claim to be without sin, we deceive ourselves and the truth is not in us. 9 If we confess our sins, he is faithful and just and will forgive us our sins and purify us from all unrighteousness. 10 If we claim we have not sinned, we make him out to be a liar and his word is not in us.

If we are to rid our world of evil first we have to address it within our own heart first.

Romans chapter 3 verse 23 says that all have sinned and fall short of the glory of God, however verses 24-26 reminds us of the great love our Creator Father God has for us that Jesus paid the price for our redemption and we can only stand before Almighty God if we repent and receive forgiveness through Jesus and be cleansed and made whole and worthy and pure through him. For this next season we are about to enter we need God's divine help and guidance.

In **James chapter 4 verse 8** Draw near to God and he will draw near to you, resist evil and it shall flee

I believe that God has been divinely leading me with a way to lead the people into freedom and freedom only comes when knowing the truth.

John chapter 8 verse 32 You shall know the truth and the truth will set you free.

My role at this time is to point all to our Father God and Jesus his son where you will find love, truth, hope, freedom and peace. This first step to Freedom is knowing who we are. As we discover that our Creator God loves us and trust him wants the best for everyone of us that there is sufficient love and resources for all it removes all fear, we can get rid of selfish ambition and can start standing together as one.

1 John chapter 4 verse 18 God's perfect love casts out fear. Remain in God's love with faith and trust that ultimately he is in control and he will restore justice and bring healing.

On the nineteenth day of July in the year 2024 as the living Commander over the Crown corporations I have placed the jurisdiction of our land under Creator God Almighty in his right place and his holy word as our right and true foundation and I bring you the following proclamation.

At 5pm on the nineteenth day of September in the year of our Lord 2024 I, Janine of the House of Arabella and Walters obtained immediate Summary Judgement and immediate takeover of all assets of the following corporations and the officers acting on behalf of them **Stephen Erle Hewlett** in full private and acting on behalf of **TAURANGA CIVIL HIGH COURT** and **HIGH COURT OF NEW ZEALAND** and **NEW ZEALAND HIGH COURT** and **HIGH COURT NZ** and **NZ HIGH COURT** and **MINISTRY OF JUSTICE** and all their officers and directors

And any agencies or successor corporations set up to replace any of the corporations or debtors to prevent liability and in the event of removal or transfer of assets the lawful right to seize and claim off either the parent or successor corporations or any other corporation or individual that assets are transferred or sold to.

Where the full document of this claim of Immediate Summary Judgement was placed on the public notice board publicnoticesnz.com on Tuesday 24 September 2024 with all the public and world to see as a public Gazette and the full content of this document has been declared as truth in commerce and law with full lawful right to implement the declarations of this document.

From each of the dates mentioned above I, Janine of the House of Arabella and Walters stepped in as the living Commander over each of the corporations in the full status of a living sentient sovereign being where the corporations' directors and executive officers have been receiving instructions from me. My successful and un rebutted claims were done under the jurisdiction of Almighty God acting on his behalf and on behalf of every man, woman boy and girl living in our land known as Aotearoa and the colony of New Zealand. The corporations were given until the seventh day of October 2024 to comply and follow these instructions and every one of these corporations and their officers are in dishonour so with total and full lawful rights I hereby proclaim and declare to all men and woman and their offspring living in the colony of New Zealand and on the earth on the eight day of October 2024 the following statements and declarations:

That the I Janine the living Commander of the Above listed corporations provided the means to pay off the National Debt on the nineteenth day of July 2024 and due to the officer with instructions not complying and paying off the national debt that from twentieth day of September 2024 actioned with full lawful right the cancellation of the national debt over every man, woman, boy and girl plus actions backdated to 19 July 2024.

That the officers of the listed corporations were instructed to reduce all forms of personal and income and goods and services taxes to maximum of ten percent by the seventh day of October 2024 and this did not occur, so with full lawful right as the Commander I now cancel all personal and income and goods and service taxes that have been placed on the people due to all of these being charged fraudulently and these taxes can no longer be enforced with individual men and women having the right to charge an officer or agent who tries to enforce fraudulent and cancelled taxes upon them with all past taxes owed and student debt cancelled from 19 July 2024.

That I Janine the living Commander of the above listed corporations ordered their officers by seventh day of October 2024 to reduce property taxes to maximum of one thousand per year per property backdated to nineteenth day of July 2024 and I confirm this did not occur so with full lawful authority I cancel all property taxes altogether due to fraud backdated to 19th day of July 2024 and any past charges or debt owed is cancelled backdated to 19 July 2024.

That backdated to nineteenth day of July 2024 fuel tax as well as road user charge and toll charges public parking fees can no longer be enforced with individual men and women having the right to charge an officer or agent who tries to enforce these fraudulent charges so that travel on New Zealand roads and parking be free for freedom of movement throughout New Zealand.

That I Janine the Commander of the above listed corporations and their officers ordered their officers backdated to nineteenth day of July in year of 2024 to drop all speeding and parking and property fines and declares that speeding and parking and property fines can only be charged where a crime of harm against another individual can be proven, and the people are now informed that speeding and parking and property fines are not enforceable unless a crime of harm has been committed, and this will stop intentional revenue making off the people. That the police are reestablished as peace officers and councils and the courts of New Zealand return to serving the people and preventing harm rather than revenue making.

That the original meaning of the word LEGAL was in an 1893 Dictionary of Arts and Science and Encyclopaedia Britannica 1893 volume defined as 'the undoing of God's law' or the removal of God. As we are now under Jurisdiction of God almighty and God's law through the Holy Word of God the legal system is now abolished over the people as it is only crown law which is corporate law that only controls corporations.

That I Janine as the living commander over the Crown corporations call the fraud in the Crown property titles where men and women have been deceived into believing they are buying a property where in actual fact they only hold the document title with geographical markings not the land underneath and the land deed has been withheld from them. Wherever fraud is found documents and titles they become null and void and all crown property titles now revert back to the unextinguished native titles. To protect individuals who have innocently bought property believing their titles to be correct and true they are assured that if they are living on a piece of land they retain the right to keep living on that land where individuals will be shown the process shortly to claim full living rights to remain living on that land.

That as a result of crown titles becoming null and void then mortgages all become null and void due to fraud and deceit. That payment on mortgages can no longer be enforced, and banks and officers working within the banks can be charged for fraudulently continuing to remove funds from bank accounts including taking out fraudulent property taxes. To perfect the law I Janine as the living Commander of all the listed Crown corporations confirm that Crown property titles are now obsolete due to fraud and the mortgage is attached only to the Crown title and so now the Crown title is obsolete the mortgage is also obsolete. To make certain there is no misunderstanding a repeat this a third and final time. Mortgage documents and Crown land title documents were created fraudulently and anywhere there is fraud the documents become null and void.

That if bank corporations continue to charge people for their mortgages which are now null and void the people can lay a charge of harm against the banks and their officers. That if banks are to continue to function they have to show they are willing to work honourably. Banks are no longer to operate as fraudulent debt collectors as they will be charged for being fraudulent third party debt collectors.

That all my past documents were created as living documents only under the jurisdiction of Almighty God and his Holy scripture where upper and lower and title case don't matter, what matters is the truth, where each defendant had the opportunity to rebut and they didn't and as there was no rebuttal my documents stand as truth in law and commerce where the commercial charges still stand and continue going up ten percent per week until settled in full with the lawful right to add further charges of harm as the full truth comes out.

That all the assets belonging to the above listed corporations are now placed in Janine's Trust where I Janine am the settlor and all people living in our land are the beneficiaries for the use and benefit of the people and if an officer of a corporation or agent acting for any of the listed corporations tries to steal any of the assets they can be charged with theft or a whole series of other charges. The corporation property asset lists will be added today so that all people know what now belongs to them as beneficiaries and they can notify me of any unlawful sales notices or activity.

That I Janine as the living commander over the Crown corporations declare that I have all my affairs in order with a successor to step into this role in the event something happens to me or to act on my behalf if not able to be present to action any orders, and my successor has someone to step into the role of Commander and so on, so the actions and orders can not be stopped until all actions and claims of harm are addressed.

That a committee of people now be set up to address harm done by the covid 19 vaccine where men and women can make a commercial claim of harm with evidence for deaths, severe adverse reactions, discrimination, loss of employment and livelihood and these claims lodged with the committee who ensures all claims are genuine where all must be paid out or the individual can request their payout to be taking over one of the Crown corporation assets.

That the roll out cease immediately of all mandated vaccines including children and elderly and flu vaccines until full disclosure is provided what is in these drugs, the rate of success and effectiveness of each drug and profit margin plus all alternative health and treatment options with the same information, that Big Pharma no longer controls people's choices for health and wellbeing.

That if ASB Bank doesn't immediately release fifteen billion dollars into a housing fund overseen by me the living Commander then all ASB Bank assets will be liquidated including those of its directors and Chief executive officer. ASB Bank has in their possession on the True Bill Ledger the bank account number for depositing called House of Talia Dawn Private Foundation.

That I Janine the living Commander declare that no fluoride or any other harmful chemical can be added into any drinking water or waterway and any officer or agent of any corporation that tries to enforce this will be charged with crimes against humanity plus commercial charges of harm and that every man and woman has the right to lay charges of harm against any man or woman who tries to do this with immediate effect using my liability notice with compensation charges which is found attached to this document on the public notice board publicnoticesnz.com where this and other documents will be constantly evaluated and simplified for use.

That recently Nicola Willis in the role of Finance Minister released the information to the public about the profit margin mark up that the power and communication corporations were making and some of these corporations

are partly owned by the Crown, therefore I Janine as the living commander over the Crown corporations orders the profit margins be lowered of the Crown energy and communication providers to maximum of 20% mark up for monthly charges on power, communication such as telephone, mobile and internet that every household and individual has the means of communication for his/her essential needs and to communicate with their loved ones wherever they be in the world. That will set precedent for all other energy and communication providers.

That to date the media has been controlled by corporations outside of our country and we now hold all men and women who work for any type of media that from this date being eighth day of October 2024 that if they spread any false information with the intent to deceive and cause harm they can and will be charged as individuals as well as the corporations they represent where commercial liability charges of harm will be worked out according to their coverage reach and these corporations will quickly be liquidated and assets seized and taken over if this continues. They are now commissioned with telling the truth and no longer causing harm.

That anyone acting on behalf of any corporation that does any action that causes harm to our people or our land or our food, our water, our animals, our plants, our air or any other resources that we need for survival they can and will be charged and held accountable. That the list of ingredients needs to be listed going into foods, medications or products going in or into our bodies plus chemical sprayed on our plants, where if products do not list this information they can be removed from the market and if any product contains harmful substance products they shall be removed from the market.

That the pilots and the corporations they are acting on behalf of any plane or flying aircraft that continues to spray known or unknown harmful substances into the sky they can and will be charged where people can put in rightful claims of harm under God's law, and planes can be taken off these corporations and given to the people for use for good instead of harm.

That the officers or agents acting on behalf of any corporation using any type of technology to manipulate our weather or the earth to cause harm will be charged where the technology or devices or products causing harm and any assets of these corporations can be seized by the people who put in rightful claims of harm under God's law.

That any other matter that I have forgotten to mention where a man or woman does any type of harm on behalf of a corporation both the individual and corporation can be charged by people putting in rightful claims of harm under God's law. I also say here that no officer of any of the corporations can give orders without my written authorisation and any orders given are null and void if not authorised by me and I did not authorise the Crown corporations to join our country to United Nations so we remain independent and sovereign.

BE IT KNOWN THAT on 28 October 1835 on our land known at that time as Aotearoa a declaration of Independence was signed between King William 4th and Hongi Hika where King William agreed that the natives living in the land would retain their sovereignty and independence and this declaration was broken down into four articles. This continues to stand as truth that can not be denied.

BE IT KNOWN THAT on 6 February 1840 the treaty of Waitangi was signed between 43 chiefs and William Hobson on behalf of Queen Victoria that was a trading agreement where land was able to be purchased for the white man to settle based on Queen Victoria providing the natives protection and maintaining their independence and sovereignty to manage their own affairs. The maori translation was different than the English translation and the native translation is the true recognised version.

BE IT KNOWN THAT some native land deeds were sold lawfully to Tauwiwi coming to live in this land. Tauwiwi means the people who have come from overseas.

BE IT KNOWN THAT some native land was sold unlawfully or seized without any payment to the native people

BE IT KNOWN THAT since this time that the Crown corporations have made some large land settlement payments to iwi to try and correct wrongs of the past.

BE IT KNOWN THAT since this time many innocent Tauwiwi have purchased land in this country.

BE IT KNOWN THAT Queen Victoria did not honour the agreement to provide protection for the native people where armed forces rose against them to remove them from their own land which make the treaty null and void with land wars occurring 1843-1872 where there was loss of life and large blocks of land forcefully confiscated off the native people.

BE IT KNOWN THAT there have been many wrong land confiscations where some have been acknowledged and have received settlement and compensation and others haven't, and that all unresolved land claims must be settled and compensated.

BE IT KNOWN THAT God created the land and no man can own land, he can only live on it and take care of it and be guardians on it. God created men and women and men and women created corporations and a corporation can never have control of a man or woman. When God created men and women they were supposed to protect and care for each other and the land, that all men and woman were created equal with no one having the right to control another.

BE IT KNOWN THAT the principle of the original treaty agreement was that guardianship of the land was going to be done in partnership, however the white man and corporations took over that control. Crown corporations have tried to administer the affairs of men and women and land but done it in such a way to cause harm and slavery and hardship and have demonstrated poor guardianship of this land and never held the lawful right to do this. The guardianship of the land is now returned to a partnership agreement with all native people where to obtain harmony need to enter into a new treaty agreement that will start as a 50/50 agreement between Mauri and Taiwi until such time it is determined true percentage of guardianship that each man, woman and tribe hold where I bring the assets that belong to the corporations to be also held in trust on behalf of the people. Mauri are the native people form our land and Taiwi are the people who have comes from overseas to live in this land.

BE IT KNOWN THAT whoever has bought land with honest intent and paid market value continue to have the right to remain living on that land. That all have the right to make a land claim to become guardians of the land.

BE IT KNOWN THAT the Mauri people are now restored back to the original 1835 declaration of Independence with the lawful right to sovereignty and independence. This first agreement was with one white man – King William where this agreement was made with mutual love, respect and trust. The Mauri Nation are now free to govern their own people, no longer under Crown law and can make their own law. I encourage you to keep it simple, don't fall into the trap of copying their system, ask how you would like things to be, place people in leadership that demonstrate the values love God and love their neighbour as themselves. The second agreement in 1840 presented by another white man was made using deceit and greed. We can not change the actions of the past however we can choose to change our future.

BE IT KNOWN THAT I wish for Mauri People to consider partnering with me Janine as a white woman who wishes to stand on truth and honour and with mutual love and respect where the Crown and corporation assets which are now under my control are placed in a trust where we appoint some Mauri and Taiwi to be care takers of these assets, where we agree that going forward from this day we are under the law of God where all the law is summed up with loving God and loving our neighbour as ourself where we recreate our country and local communities to a place of freedom, where we love our Creator God, love our neighbour as ourself and do no harm. Once we free ourselves of restraints just imagine how we can be where we don't have to compete for resources, there is sufficient for all. Our starting point is stepping into our own freedom and independence and sovereignty, then finding a way to live in unity with others. The Mauri people have a large role in achieving this and I want to see all restored and come to a place where we can leave the past behind to move towards an exciting future of creating what we have always wanted – love, peace and harmony which starts with everyone of us, and I will be attending Waitangi on 28 October 2024 by invitation, and also hope to have a private meeting with our new Mauri queen of how we can work in partnership.

BE IT KNOWN THAT I am setting up a place to meet on 26 October 2024 with all who are interested Mauri and Taiwi to find our way forward, find our shared values and common goals and what each other's interests are as we need the assistance of everyone to address all the needs of our country and I am doing this in conjunction with Lady Crown Turikatuku III from Nga Puhī.

Now I wish to speak on a personal level **Firstly**, with my hand on my heart, I would like to take this opportunity to acknowledge the past injustices and the massive consequences that have been occurred to the Mauri people, where their rights and freedom were wrongfully taken away. The first step in healing is full acknowledgement of the wrongful deeds of our past. I Janine with full sincerity humbly apologise to all Mauri peoples of Aotearoa (New Zealand) for the injustices, breaches, theft of land, slaughtering of their people and crimes committed against them by the colonists and my forefathers before me. It is for this reason that I make this proclamation at this time.

I would like to tell you a little about my journey that has lead me to where I am today. I grew up in a home with a loving mother and father who believed in me and taught me I could do anything. I took this strong belief into my life, however another member in my family was in a bad space due to significant trauma that happened to him before I was born, where from day one he chose to hate me and treat me badly and I developed the belief that I am worthless and I ended up marrying someone who treated me this way. Our life experiences shape us, but it is actually our beliefs around those experiences that really shape us. I took on that I was worthless until much later God showed me that I was lovingly created by him that things changed for me. In order for me to heal and change my future I had to change my beliefs from being worthless to one deserving of love and being treated differently. After my first marriage broke up I discussed with my children and my parents that I would like to change my name and with their full support I changed my name to 'Arabella' which has two meanings -lovable and God is faithful and he answers prayer. Up until that time I had tried to do what is right and I made a decision to trust God that he would turn things around for good, and that he would bring a man into my life who truly loved me and that I would be fully restored in every capacity. I met Richard in 2012 and he is definitely a man who loves me and supports me who I am proud to be have by my side.

The reason I am sharing this story is realising the power of words, I changed my name and my view of myself and I changed my destiny. Way back near when the white first came here they gave you the name Ma-ori which was not in your language before that time. I have had one of your people break down the meaning of the word. It means victim and from that time you were victimised. You have the power to change your name and change your destiny. Some of your people have started calling themselves 'Mauri' and this means the essence of life. I wish to share that "Ma" means "first" and "Uri" means one's vital essence—the Crown, the first breath. Start seeing yourselves as Mauri that are the essence of life where you have the ability to recreate life the way you want it to be. You are no longer victims.

Again, 'Pakehā' carries a negative undertone, as 'Pa' means 'to block or obstruct,' while 'Keha' refers to 'a blood-sucking insect.' This implies us being blood-sucking insects. Here is a more positive term for people like me 'Tuiwi'. Tuiwi means people who have come from overseas. Let us start viewing each other differently as we all at some point came from overseas to be here. If we start viewing each other differently rather than being enemies and looking at our differences let's find our common values.

I remember well one of my first proper overseas travel where I went to America first starting in Florida and Georgia then moving right up the east coast to New York and was fascinated as the people were just like me – we had the same hopes and dreams, wanted peace and harmony, wanted the best for our children. Let the Mauri in our land and the Tuiwi start viewing each other as most of us wanting the same things. As we connect with each other and listen to each other's hearts we will discover that we are all alike.

The other matter I wish to share is that I started this journey of justice as a grieving mother wanting to hold people and the corporations they work accountable for their actions. My initial place was one of anger and wanting vengeance against the people who harmed my daughter. At some point I needed to address the evil within my heart and that vengeance was a wrong motive and had to ask for God's help for me to forgive so that I could continue the actions I am taking with pure motives where justice and mercy are in balance so if the people who have done harm are willing to own their actions they have the opportunity to make amends.


God showed me his way is one of Love, Freedom and Choices however with freedom of choices comes full accountability and if we make amends we can be restored. This is the path we need to choose. We need to



acknowledge the evil within us first if we are to stand and fight against evil and realise that we are all here by the Grace of God and we all need him in our own personal lives plus to help unify us and help create a world with love and peace and harmony that can only be achieved through him. I encourage all to do the same.

God has given us an amazing opportunity to do things his way, this is not the time to copy anything from the system we have known but to start with a blank slate where our foundation is that we were created by God and his two greatest commands are love the Lord your God with all your heart and soul and mind and love your neighbour as yourself. The way forward is love, forgive, make amends and unite. People let us unite as one!

I Janine of the House of Arabella and Walters have made this Proclamation as the Commander of the listed Corporations before three witnesses and before Almighty God knowing the contents to be true and correct with first-hand knowledge and innerstanding "So-help-me God" with the right to correct any honest made errors or mistakes.



