Liquidation Court Summary Judgement of Sanjai Raj dated 14 January 2025

This court hearing in the Royal Court of New Zealand under the jurisdiction of Almighty God and all its content have been entered into the public records. Court recording commenced at 4.03pm on the fourteenth day of January in the year of 2025.

From the word of Holy Word of God it states in Matthew Chapter 18 v16 and 20 "A matter shall be established by two or three witnesses." The two witnesses attending agreed to act in this capacity and gave their first names Fred and Beverley-Jane.

Sanjai Raj was charged on the third day of December 2024 as Individual in Private as well as Registrar of Personal Properties Securities Register and all Associated Corporations for attempting to cause loss by deception which is a crime involving deceit under s.240(1) Crimes Act 1961 for removing 103 financial statements, of the debts associated with the Crown corporations and their officers and ministers. This is a criminal and imprisonable offence on top of the commercial charges already in place. It is also noted that the date chosen to remove all financial statements was the day before the commercial lien against the Prime Minister Christopher Luxon reaches the 90 days which makes this a criminal offence, therefore he actively participated and aiding and abetting this crime. In his role as Registrar he is also subject to the 1961 Criminal Justice Act drawing particular attention to sections 98,100, 105F, 219, 240, 242 and 116 Conspiring to defeat justice 'Every one is liable to imprisonment for a term not exceeding 7 years who conspires to obstruct, prevent, pervert, or defeat the course of justice in New Zealand or the course of justice in an overseas jurisdiction.' There is a charge of harm on behalf of every man, woman boy and girl living in New Zealand for trying to steal and cause loss by deception of their rightful claims. The current population is 5,338,000 approximately with a seven year charge for each one. The sections mentioned of the criminal Justice 1961 Act were entered into the public record in full.

Due to fraud and deceit Sanjai Raj became personally liable for the full debt against all the crown corporations, plus made the corporations he represents fully liable for his actions. Through discovery it is found that he represents the Companies office, which also has international ties, and as further investigations occur any other corporations nationally and internationally that are

associated with the Companies Office are also liable for this debt including the international banks. Due to the serious natures of the crimes where every man, woman, boy and girl on earth has had a corporation set up to represent them through fraud and deceit to make them debt slaves the debt continues to go up until it is settled.

The total amount of debt owing on the seventeenth day of December 2024 of the Crown and council corporations related to the financial statements that Sanjai Raj removed off the register was two hundred and forty-two quadrillion, seven hundred and seventy-one trillion, eight hundred and forty-four billion, eight hundred and ninety-six million, four hundred and eighty-five thousand dollars in numbers \$242,771,844,896,485,000.00. Sanjai Raj was informed that on the statement of money owed provided to and received by him on sixth day of December plus placed on public gazette that the debt would continue to double daily until settled. This has continued to double from 18th day of December and has a current charge today on 14th day of January 2025 of 65.168 septillion new zealand dollars (\$65,168,570,888,700,000,000,000.00NZ) and now that through discovery there is international ties this figure is converted into US dollars which is 36.494 septillion united states dollars (\$36,494,399,697,600,000,000,000.00usd) with an official lien made against the companies office on the UCC.

Sanjai Raj's non action and dishonour on behalf of the Companies Office has created massive world debt which is going to lead to the whole world monetary system collapsing. Sanjai Raj is personally liable for this debt.

Today being the fourteenth day of January 2025 seeking first the Kingdom of God the Summary Judgement now of failure to pay the outstanding debt due and owing in due course a charge over the whole of the assets, liabilities and rights in the Crown of Her Majesty Queen Janine who assumes Creditor's Rights has affirmed in the Royal Court of New Zealand for the restoration of God's Kingdom here on earth within the realms of the United Kingdom of New Zealand assents to the place of Royal Assignor and Royal Assignee in the Crown of Her Majesty Queen Janine of the Royal House of Walters to administrate the liquidation of Sanjai Raj for his role in making the inhabitants debt slaves with failure of payout and failure of serving the best interests of the beneficiaries, where from the Holy Bible the book of Matthew chapter 6 verse 33 declares that as we seek first the Kingdom of God and His righteousness that all these things shall be added to us being God's people and the inhabitants of Earth.

Today being the fourteenth day of January in the year of our lord two thousand and twenty five at 4.15pm it is entered into the Royal Court record that Sanjai Raj was declared insolvent that from this day he is no longer able to hold positions of authority, or remain in the office of Registrar where all and any assets or shareholdings and voting rights are now allocated to the Assignor Janine of the Royal House of Walters. Sanjai Ray has now entered into statutory management where his roles and titles and office are now taken over by the Royal Assignor Janine who takes over with immediate effect the role of Registrar in the Companies office which means with immediate effect that all decisions and operations need to have her approval or they are unlawful.

The Companies Office is notified today on 14th day of January 2024 of the debt outstanding that Sanjai Raj has allowed to accumulate without reporting to his superiors, that the companies Office is now liable for where the Chief Executive Officer and minister of the Companies office are required to provide a full report with statement of financial affairs and full list of assets and liabilities, provide every register public and private and crown and admiralty plus any overseas register plus any other register that contains information regarding the corporation's financial

operations with personal and criminal liability for not providing this information couriered to the service address of the Assignor by 4pm on Friday 17th of January 2025.
