Orders to Sanjai Raj from the Royal Assignor

You were declared insolvent in the Royal Court of New Zealand on the 14th day of January 2025 where the court notice was sent to you that same day plus a hard copy sent via courier post received on the 20th day of January 2025 at 1.03pm.

As you have been declared insolvent you are no longer able to hold office and the title of Registrar has been taken from you, where I, Crown-Janine the Royal Assignor with full lawful rights step into this role. You are required to report this to all other officers within the companies office and all superiors. It will depend on your actions from this point as to whether you will be terminated from employment due to committing 103 crimes of attempting to cause loss by deception plus conspiring to defeat justice plus guilty of the crimes of debt slavery which made you personally liable for the Crown and council corporations debt and ultimately led to your insolvency.

A letter was sent from the PPSR office dated 20th of January 2025 and signed by your signature showing that you are unlawfully practising as a Registrar with authority you no longer hold and are also threatening to remove more lawful commercial liens through fraud and deceit.

As the Royal assignor you have now entered into statutory management with full accountability and reporting to me. As the Crown and council corporations have been declared insolvent and also gone into statutory management these companies now need to be managed by me the Royal assignor. You are ordered to provide me with access into the New Zealand Companies Office buildings in Auckland and Wellington and confirm if you are based in the Auckland or Wellington area. You are ordered to provide me with a master username of Crown-Janine which is emailed to me at

nowfreedomforall@protonmail.com with a temporary password that I change which grants me full access and authorisation to place my name as the Royal assignor as the Official Assignee alongside the crown corporations and alongside the shareholdings of the crown corporations. This action needs to be done by the end of 4pm 22 January 2025. As long as you comply and remain fully accountable to me you will be able to continue employment as an administrator as long as you stop using fraud and deceit otherwise we will proceed to criminal sentencing as already have evidence of your crimes. As you are insolvent I also have lawful authority to take your property to pay off on your debt. It is depends on your actions at this time to how severe the consequences will be. Attached is the credit notice that you are also required to fill out and send back to me.

You are also informed that on the 17th day of January 2025 the Companies Office and Ministry of Business Innovation and Employment were also declared insolvent due to your actions as Registrar making them also liable for the debts of all the commercial liens with court hearing summary on publicnoticesnz.com.
