

1. **Therefore I declare that** I have placed this country and these courts and the government of this country under the Jurisdiction of Almighty God with the Holy word of God from the Bible as the highest authority where Crown corporate laws shall become obsolete when any lies and deceit is found in any man made laws and contracts. 

Dear Kerry

Taupo District Council will not be withdrawing the Rates Invoice Instalment notice (1 of 3) for the period 1 July 2024 to 30 June 2025 and your suggestion that Janine Barbara is the Council's "Leader and Chief" is rejected. This has no legal basis and is without merit.

The Local Government (Rating) Act 2002 (LGRA) provides the Council with the power to set, assess and collect rates to fund the activities of local government. Under the LGRA, the Council is required to assess all properties in its district for rates. A ratepayer for a rating unit is liable to pay the rates that are due on the unit. This is a statutory requirement which does not require any consent from the ratepayer concerned, or indeed any other person claiming to have authority (such as the Janine Barbara you refer to).

The Council will not be entering into any further correspondence with you about this matter, other than to issue you with further payment reminders and/or penalty notices should rates not be paid.
