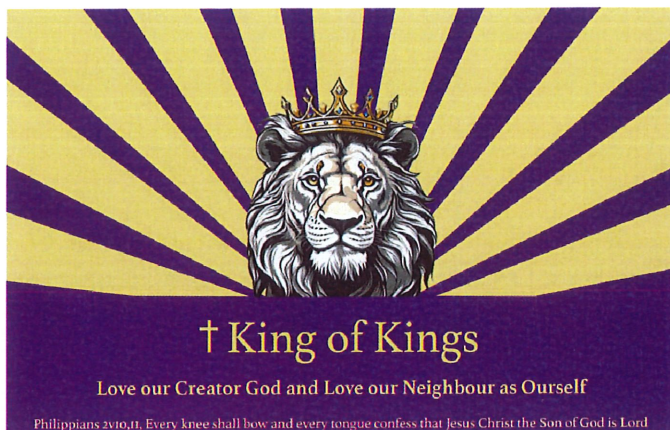


•LIVE•LIFE•CLAIM•

Notice
