LIVE LIFE CLAIM of Kipa of the House of/Whakapapa King

I, being Kipa, of the House of King, call upon The Father, The Son, and The Holy Spirit as witness to this Claim. I am the live, living claimant, executor, beneficiary, Settlor, Trustee, and Heir of my estate and trust by the Christian name Kipa. I affirm before The Divine Father, Lord and Creator in Heaven — Almighty God (Io Matua Kore) — that I am a live, living sentient soul, with a body of flesh and flowing blood in the form of a man, of sound mind, above the age of consent and capable of managing my own affairs, living on the Land (Whenua) known as Aotearoa, New Zealand, not subject to corporate Crown law, commercial or foreign jurisdiction.

I retain full lawful, spiritual, and equitable title over all property, identity, and rights associated with the estate. I do not act as a minor, ward, decedent, or corporate entity, nor do I stand in the capacity of a beneficiary subject to external administration. I am competent, of sound mind, and fully capable of administering my own trust, affairs, and responsibilities.

"I, being Kipa, am a live living lineal descendant of the House of King with the live born names being Kipa born on the 30 day of the month of June in the year of Our Lord nineteen sixty-three [1963] within the location of the town known as Wairoa in the region of Hawke's Bay on the Land (Whenua) known as Aotearoa New Zealand.

"I, being Kipa, am of the House of King am a live living offspring to my mother being Kate of the House of Marsh and my Father being Rai of the House of King.

I, being Kipa, am the biological father and living guardian of two sons, born of my seed and entrusted to me by

Almighty God (Io Matua Kore).

- I, being Kipa, am the biological father, spiritual guardian, and sovereign authority over my two living sons:
 - Taika Alexander Smythe-King/Taika of the House of King
 - Gabriel Kahu Smythe-King /Gabriel of the House of King

with Christian names of Taika and Gabriel were born of my flesh and my bloodline, are from the clan/Hapu of Smythe and King which are the family names of the mother's bloodline and me being the father's clan/ Hapu of King. Their names, DNA, spirit, future, and identity are under my lawful and ancestral protection, and cannot be surrendered, registered, nor claimed by external agents, courts, states, or statutes.

Proof of Claim:

"I, being Kipa, of the House of King do affirm that this picture and this thumbprint made with my blood of my right hand/hair sample showing DNA and this autograph are truth with this LIVE LIFE CLAIM.

This claim is made with full knowledge, by free will, and stands as truth under Natural Law, God's Law, and Customary Law (Tikanga), and under the authority of the He Whakaputanga.

Supreme Claim on Soul and DNA

I, being Kipa, hereby declare absolute and irrevocable claim over my DNA, my genetic code, and the souls and biological essence of my sons. I do not consent to any harvesting, alteration, trade, study, storage, replication, manipulation, or registration of my DNA or that of my offspring (Tamariki).

Redemption through the Messiah

Colossians Chapter 2 verses 14–15: "Blotting out the handwriting of ordinances that was against us, which was contrary to us, and took it out of the way, nailing it to his stake; and having spoiled principalities and powers, he made a shew of them openly, triumphing over them in it." Through the redemptive act of the Messiah upon the stake, I declare all presumed debts, bonds, contracts, or corporate representations imposed upon me without knowledge or full disclosure to be void and of no lawful force or effect.

I, being Kipa, also declare that I am not an artificial person, I am not a corporation or subject to corporate crown law and that any previous consent or contract given by my hand is null and void as at the date of this LIVE LIFE CLAIM, and I take away the administration of any other man, woman, agent or corporation from managing my own estate and affairs where all powers of attorney have returned to me and declare that I am the only true heir and executor of my estate and trust, plus I am the Secured Party Creditor, not the debtor and not surety to any debt. I also claim my DNA and soul back to my Creator Almighty God and through confession of my sins before Almighty God (Io Matua Kore) have received the forgiveness of sins and have requested the blood of the son of God Yeshua (Jesus Christ) to fully cleanse me to fully restore me, my soul and my DNA completely back to how Almighty God (Io Matua Kore) created me to be and have asked for Almighty God's (Io Matua Kore) healing power to flow through me and restore every cell, system within my body and that as I renew my mind through the Holy word of Almighty God (Io Matua Kore) that my soul be fully restored so that the peace and love and joy of Almighty God (Io Matua Kore) be within me.

Under the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP):

I, being Kipa, assert full attorney-power and copyright over the names, birth registrations, and any derivatives related to myself and my sons. Any use of the names, estate, biological data, or registration numbers associated with us, including use in legal or commercial processes, without my express written consent is unlawful and subject to charge. Notice of Withdrawal of Consent

I, being Kipa, hereby withdraw any and all presumed or imposed consent to be governed, regulated, or interfered with by any state, court, government, or foreign jurisdiction in relation to myself or my offspring. This withdrawal is permanent, irrevocable, and made knowingly, voluntarily, and by the authority of the living man (Tangata Whenua). No further contact or involvement is permitted without written consent issued under my living hand and seal.

Notice
