- 1. That fraud was found in an ASB mortgage document instrument 12324652.3 and with full lawful rights the instrument was made null and void. If it becomes void and if an officer or agent continue to try and enforce payment of fraudulent principal or interest the officer or agent become liable for the associated debt, where the debt owed by ASB BANK and ASB HOLDINGS at the time of their insolvency was two hundred twenty-eight trillion, seven hundred sixty-six billion, six hundred eight million, six hundred fifty-five thousand, six hundred ninety-eight dollars with ten percent per week accruing penalty interest added from 18 December 2024 to 15 July 2025 the final date for payment for all other associated parties who became liable for this debt; and
- 2. That the amount owing on 15 July 2025 was two quadrillion, seven hundred and twenty-six trillion, four hundred and eighty billion, eight hundred and twenty seven million, eight hundred and ninety-five thousand, seven hundred and sixty dollars (\$2,726,480,827,895,760.00NZ), where the bill was received by all of the defendants and final bill showing monies owed on 15th day of July 2025 is attached as Exhibit A. Each of the debtors and defendants had until 15 July 2025 to make payment, or rebut and/or place a defence and it is confirmed before the court and the three witnesses that no defence or rebuttal or payment was made by the due date.

- 3. That this debt came about due to actions of staff and directors of ASB BANK and lawyers and associated corporations and trusts and societies acting on their behalf being complicit for acting as fraudulent debt collection agencies and enforcers of a falsified fraudulent debt as well as allowing ASB BANK to continue trading while insolvent and all the corporations/trusts/societies they act on behalf of have commercial liability, when they are acting in dishonour and using fraudulent joinder on behalf of an insolvent bank, they remove all immunity from being charged in their personal and individual capacities for criminal and commercial offences. There are charges of conspiring to bring false accusation and to conspiring defeat justice as well as complicit in theft and dishonestly taking or using a document to obtain pecuniary gain and obtaining and causing loss by deception which are all crimes according to Crimes Act 1961. All of the debtors and defendants are now individually and in their private capacities liable for ALL of the debt owed by ASB Bank at the time of their liquidation on 18 December 2024 with ten percent per week accruing penalty fees applied; and
- 4. That the mortgage instrument 12324652.3 was cancelled with full lawful rights on 1 December 2023 due to fraud, non rebuttal nullifying this instrument and the associated mortgage and loan where penalty charges were added every occasion funds were fraudulently withdrawn from RICHARD AND JANINE WALTERS FAMILY TRUST bank account being 12 -3491-0044887-00 on the 18th of every month. ASB BANK were given every opportunity to remedy this matter with a series of at least 6 commercial affidavits plus monthly bills sent that ultimately led to placing an Admiralty Statement of Claim in the High Court with full summary Judgement awarded on 18 July 2024 and evidence of payout on 19 July 2024 where the ASB BANK shut down trading for the day and actually stole billions of dollars and may be complicit in theft of trillions of funds on this day in collaboration with Nicola Willis the finance minister, where a full robust forensic analysis is to occur to find out the identity of all parties involved in theft on that day where it is already known that both Vittoria Shortt and Nicola Willis were involved and are subject to criminal charges for theft not only of funds owed to the Claimant Janine of the House of Walters but also to every man, woman, boy and girl in New Zealand; and
- 5. That ASB BANK and its agents used DOGMA latin and unlawful conversion of the names of Janine Walters and Richard Walters as guarantors on the ASB loan documents with non-disclosure and non-consent, where nondisclosure, non-consent and fraud makes any contract null and void, as well as all assumed powers of attorney and guarantees null and void; and
- 6. That ASB BANK and its officers created funds that did not exist prior to the wet ink signatures on the loan agreements signed and committed fraud and through non rebuttal of the high court served documents it has been confirmed via tacit acceptance that ASB BANK did not lend anything of substance, that ASB BANK was paid out in full at the time the loan was granted so there was therefore never any money owing or monies due and all charges from the time the loans were first granted in 2012, 2016 and 2021 are fraudulent with all actions constituting as unauthorised access, theft and breach of trust, thereby removing private immunity; and
- 7. That an email was sent to Lia Lee and Vittoria Shortt from ASB BANK on 24th day of April 2025 stating that the claimant Janine of the House of Walters wished to settle the matter of any outstanding proven debt claims of ASB Bank and have this offset against the debt owed to the claimant where the difference required to be paid out in full to the Claimant and Statutory Manager being Crown-Janine of the Royal House of Walters of the debt owed from ASB Bank where Vittoria Shortt was to inform all directors of the situation and arrange a meeting of all the directors by 30 April 2025. Vittoria Shortt and all of the directors refused to meet with the claimant and Statutory Manager and refused to settle this matter; and
- 8. That all lawyers and barristers and law firms and individuals their associated corporations and trusts and societies that they hide behind are fully aware of the facts of this case and are no longer protected and where it is found that they are acting with intent to harm and deceive and obstruct the course of justice every officer and agent and staff member and employee is liable commercially and criminally in their private and individual capacities as well as the corporations and trusts and societies they represent also being commercially liable; and

Case officer: Royal Assignor and Assignee in the Crown of Her Majesty Queen Janine of the Royal House of Walters who currently also appointed as Statutory Manager

The directors and trustees and chief executive officer Lisa Jacobs now have ten working days to provide the financial and operational records of public and private ledgers before becoming criminally and personally liable for the debt and will then face personal liability and insolvency. The individuals also have ten working days to provide the financial and operational records of public and private ledgers before becoming criminally liable and a warrant out for arrest. There is also the lawful right to go after parent and successor entities.

All men and women in the private have a right to appeal the court decision and be formally trialled in front of their peers with the knowledge that if trialled in front of peers in the Royal Court under the Jurisdiction of God Almighty that the charges already in place commercially due to evidence of harm and loss will lead to sentencing for the criminal charges of harm. If the man or woman shows remorse to their actions or decisions or lack of actions then he or she will have the opportunity to communicate their commitment to help undo harm, and victims will have the opportunity to declare his/her victim impact and the court will decide on the appropriate sentencing. Following orders is not an acceptable reason for an appeal for all are accountable for his or her own actions.

As all the officers are now declared insolvent and now entered liquidation and statutory management all their roles as partner, director, officer, lawyer, solicitor or barrister have now become vacant, where once made insolvent are not able to hold positions of authority. The Royal Assignor Crown-Janine steps in to fill this role until she appoints someone else into this role. The Court makes it clear that the men and women made insolvent can not be appointed into any other roles or portfolios and any decision he or she makes from the time of insolvency is unlawful and is considered revoked unless the Royal assignor or appointed Statutory manager approves that decision in writing.

The three witnesses attending with names Margaret, Fred, and Karl agree and confirm that all the information presented in this hearing is true and correct that the debtors failed to settle their debts and as a result with full lawful authority have been declared insolvent at 4.23pm on Wednesday the sixteenth day of July in the year of 2025. The hearing closed at 4.31pm.
