I, Janine of the House of Arabella and Walters have the lawful right of claim of four unrebutted Admiralty Statements of Claim with Four Bill Ledgers included with Exhibit Y with the Notice of Service that have been made into Four Bill of Exchange Notes for payment. I, Janine of the House of Arabella and Walters am acting in honour with no desire to see the system completely collapse, but have found a way to hold the corporate system and the individuals that work within the corporations accountable and act in the best interests of every man, woman, boy and girl living in New Zealand. I agree to act at all times with honour and as long as individuals acting as heads for the New Zealand government are acting in honour with the best interests of the New Zealand people then I will work with them in partnership to turn this country around for the best interests of all the people living here.

I agree and promise to release the funds of one hundred and eighty billion dollars to the New Zealand Treasury on the nineteenth day of July in year 2024 to pay off and wipe the New Zealand National Debt in full based on the following fifteen conditions. Nicola Willis has four working days to respond back to my promise of honour proposal and failure to respond back by 5pm on Thursday eighteenth of July 2024 will be taken as tacit acceptance and silent acquiescence of all the terms and conditions that she is then required to act upon on the nineteenth day of July in year of 2024.

I, Janine of the House of Arabella round 9am on the morning of 19 July 2024 will turn up in person to 1 The Terrace The New Zealand Treasury to present Nicola Willis, the Minister of Finance with four bills of exchange for immediate payment including one that pays off the current outstanding national debt based on the following conditions.

That due to having full lawful right of claim I release one hundred and eighty billion dollars to the care of Nicola Willis as the Minister of Finance to pay off and completely clear the national debt with immediate effect upon payment of the four bills of Exchange BOE-JHAW-01, BOE-JHAW-02, BOE-JHAW-03 and BOE-JHAW04 by ten a.m on nineteenth day of July 2024 where it can be released in the media that the national debt has been paid off with immediate onflow effects with a proposed media release at the end of this letter. Here are the **fifteen** conditions of the loan being paid off be implemented immediately on nineteenth day of July 2024:

- 1) That the funds of the First Bill of Exchange BOE-JHAW-01 be released as follows: one hundred and seven billion and ninety-four million, two hundred and thirty-one thousand, seven hundred and ninety-three dollars and ninety-eight cents [\$107,094,231,793.98] related to unrebutted Admiralty Statement of Claim against Health New Zealand be paid by ten a.m on Friday nineteenth day of July 2024 into Kiwibank 38-9024-0122732-00 with account name being HOUSE OF TALIA-DAWN PRIVATE FOUNDATION plus due to non payment by HEALTH NEW ZEALAND Janine will take over as Commander and Chief of HEALTH NEW ZEALAND where all money received excluding Janine's own personal claim will be invested back into the health system to benefit all New Zealanders where Janine will ensure it is spent in the best interest of New Zealanders, where decisions are health driven first and foremost, and in the event of non payment further penalties keep applying with the lawful right to take over all corporations in default of payment, plus take claim off the individuals acting in dishonour.
- 2) That the funds of second Bill of Exchange BOE-JHAW-02 being six billion, six hundred and twenty-three, two hundred and four thousand, two hundred and ninety-three dollars and seventy-five cents [\$6,623,204,293.75NZ] related to the unrebutted Admiralty Statement of Claim against ASB Bank be paid out by ten a.m on Friday nineteenth day of July 2024 into Kiwibank 38-9024-0122732-00 with account name being HOUSE OF TALIA-DAWN PRIVATE FOUNDATION and as long as funds deposited on this date I will not liquidate ASB Bank but will disclose to the media that ASB Bank have donated these funds into a housing fund to help New Zealanders into their first homes, and will allocate this money for this purpose, and in the event of non payment further

- penalties keep applying with the lawful right to take over all corporations in default of payment which due to the High Court being in dishonour now includes all government corporations, plus take claim off the individuals acting in dishonour.
- 3) That the funds one billion two hundred and seventy-two million, two hundred and twenty-five thousand, six hundred and fifty-five dollars and sixty-four cents [\$1,272,225,655.11NZ] from the third Bill of Exchange BOE-JHAW-03 related to the unrebutted Admiralty Statement of Claim against Western Bay of Plenty District Council be paid by ten a.m on Friday nineteenth day of July 2024 into Kiwibank 38-9024-0122732-00 with account name being HOUSE OF TALIA-DAWN PRIVATE FOUNDATION, and I will invest these funds back into providing services and infrastructure withing the Bay of Plenty region to show by example what can be achieved and set bench mark standard for the rest of the Country of what can be achieved when spending is allocated in the best interests of the people, and in the event of non payment further penalties keep applying with the lawful right to take over all corporations in default of payment from 5pm on 20th day of August 2024, which due to the High Court being in dishonour now includes all government corporations, plus take claim off the individuals acting in dishonour.
- 4) That the fourth Bill of Exchange BOE-JHAW-04 related to the fourth Admiralty Statement of Claim against the New Zealand government corporations to be paid out as follows in two amounts with the first amount being seven trillion, six hundred and thirty-six billion, six hundred and eighty three million four hundred and ninety thousand in numerical value of \$7,636,683,490,000.00 by ten a.m. on Friday nineteenth day of July 2024 be paid into Kiwibank 38-9024-0122732-00 with account name being HOUSE OF TALIA-DAWN PRIVATE FOUNDATION with any delay in receiving payment will result in ten percent penalty fees per day until paid out in full and as soon as paid over send written confirmation of payment completed to email address janine.a.walters@gmail.com and as soon as Janine replies in writing to confirm that the full funds of the first three Bills of Exchange plus seven trillion, six hundred and thirty-six billion, six hundred and eighty three million four hundred and ninety thousand from this Bill of Exchange are showing as present in the bank account then the second amount of funds of one hundred and eighty billion New Zealand dollars can be paid over immediately into the New Zealand Treasury who will pay off the New Zealand National Debt immediately from these funds, so that the New Zealand National Debt is completely wiped and any funds left over are at the spending discretion of Nicola Willis Minister of Finance of the New Zealand Government. I promise to invest these funds back into New Zealand in partnership with the government for the benefit of all New Zealanders with a high priority of the health and wellbeing plus housing of every New Zealander plus sustainable living and ongoing producing of wealth and sustainable economy and social programmes for disadvantaged/vulnerable with goal of hand up, not hand out with principle of teaching a man to fish to feed him for life rather than give him fish and create dependence, and in the event of non payment further penalties keep applying with the lawful right to take over all corporations in default of payment on nineteenth day of September plus claim goes to over sixteen trillion dollars at that time, plus take claim off the individuals acting in dishonour.
- 5) That as soon as the National Debt is paid off on nineteenth day of July in year of 2024 that the New Zealand government announce that individual and corporate and trust taxation be reduced to ten percent for under one hundred thousand dollars of income and twenty percent for over one hundred thousand dollars of income plus goods and services taxation is reduced to ten percent and that full accountability be in place where the people of New Zealand are fully informed of spending of all claimed tax money and have a vote and say how this tax money is spent.
- 6) That from nineteenth day of July 2024 property taxes be reduced to one thousand per year per property with full accountability and releasing of the information to the people on how this money is spent with the people having a vote and say on how this money is spent.

- 7) That from nineteenth day of July 2024 petrol and fuel tax be completely removed as well as road user charge and toll charges plus public parking fees be removed so that travel on New Zealand roads and parking be free for freedom of movement throughout New Zealand and in doing so me, the benefactor will release further funds for upgrading of New Zealand roads.
- 8) That as a result of fuel taxes and road user charges and other taxes being dropped that this would have an immediate flow on effect of food and products and services in New Zealand costing less, as it is costing less to provide food and products to the people.
- 9) That from nineteenth day of July in year of 2024 the rights of every individual within New Zealand are fully restored with immediate effects of the inalienable rights of all men women, boys and girls being the right to freedom, equality and dignity, no discrimination, right to life, liberty and security, right to not be held in slavery or any form of torture or degrading treatment or punishment, right to be treated fairly, no unfair detainment, innocent until proven guilty, right to privacy, right to freedom of movement and residence, right to acquiring, possessing and protecting property, right to nationality, to marry and have family, to own things, freedom of thought and religion, freedom of opinion and expression, right to assemble, right to democracy, right to work, right to social security and social service, right to rest and holiday, right to education, right to participate in art and culture, right to freedom of travel around the world at same time respecting the rights and freedoms of others. These rights can not be taken away, and this includes freedom of speech in mainstream media and social media with censorship being unlawful and a chargeable offence unless there is proof of a crime of violence or harm.
- 10) That from nineteenth day of July in year of 2024 speeding and parking and property fines can only be charged where a crime of harm against another individual can be proven, and the people are now informed that speeding and parking and property fines are not enforceable unless a crime of harm has been committed, and this will stop intentional revenue making off the people. That the police are reestablished as peace officers and councils and the courts of New Zealand return to serving the people and preventing harm rather than revenue making.
- 11) That from nineteenth day of July in year of 2024 if someone owns land what they do on their land is their own business with no one else having the right to interfere unless harm is being done where the council officers return to serving and providing services to the community, rather than exercising control for commercial benefit and extortion. The basic principles of Health and Safety remain in place to protect individuals and the community and the land however unless it can be proven that harm or health and safety has been violated that individuals can remain in peace living on their own land without interference.
- 12) Communication- that every household and individual has the means of communication for his/her essential needs and to communicate with their loved ones wherever they be in the world, where there is a limit on profit margin of the providers to maximum of 20% mark up for monthly charges, where financial assistance is granted and services provided within six months from nineteenth day of July in year of 2024 to have a communication service set up for every household with minimum requirement being a landline and internet access.
- 13) Energy that every household and individual living in New Zealand have access to power/fuel/energy/lighting/heating/transportation/communication near the cost of producing it with a limit on profit margin of the providers to maximum of 20% mark up, where there is transparency of the costs and mark ups for full accountability and prevent harm and extortion plus full and complete transparency of impact on environment where previous decisions have been money and control driven rather that the best interests of the people and the environment. An example here is electric cars where lithium batteries have a very high cost to the environment and this information is being covered up due to other agendas of controlling the movements and whereabouts of people, plus we have unlimited resources of oil underneath and near New

Zealand that can be utilised where one major goal should be tapping into this and re-establishing oil refineries in New Zealand. That from nineteenth day of July in year of 2024 the government heads work in partnership with me to return energy assets back into the hands and ownership of the people, and implement controls immediately to limit profit margin to twenty percent on energy products and services.

- 14) Water that every household and individual living in New Zealand have the access to free pure clean drinking water with individuals having the right to choose of putting additives into his/her own drinking water, that no government or corporation has the right to add anything into the water unless 100% consensus through a vote on behalf of every man and woman living in New Zealand. I stand against any additives going into the water which means that 100% consensus can never be achieved.
- 15) That Nicola Willis agrees to meet with Janine the week of 22-26 July and Janine has the right to add any other conditions that are related to removing actions of harm towards the people of New Zealand and the land of New Zealand including the covid-19 vaccine, the air, water and plant and animal life and welfare where Nicola will work with Janine to ensure that decisions going forward are in the best interests the health, wealth and wellbeing of all New Zealanders, and that as these decisions are implemented and Nicola and the government heads are demonstrating actions of honour that Janine will release more funds back to be used for the benefit of all. I aim to be public in media about taking over Health New Zealand and paying off the country debt but willing to keep all other matters private as long as you and other heads of Government act with honour firstly with all fifteen points listed in this letter then demonstrate are acting in the best interests of the country and the people here I will continue to show support to you. I believe it is in the best interests of New Zealand to prevent a collapse and believe I has presented to you a very successful way to move forward from this point and look forward to receiving the funds on 19 July 2024 and working with you to make New Zealand one of the best places in the world to live restoring the freedom and rights of every New Zealander.

I believe every experience I have had in life has prepared me for this time to step into a leadership position with a background of twenty plus years running health services and multi million dollar organisations that have given me the skill set and character qualities to step in where I can act in the best interests of others and hope to work in partnership with you to achieve great things.

Please find attached the four Bills of Exchange being BOE-JHAW-01, BOE-JHAW-02, BOE-JHAW-03 and BOE-JHAW04 that are form part of this promissory note agreement

- 10) Water that every household and individual living in New Zealand have the access to free pure clean drinking water with individuals having the right to choose of putting additives into his/her own drinking water, that no government or corporation has the right to add anything into the water unless 100% consensus through a vote on behalf of every man and woman living in New Zealand, and there is no way possible that 100% consensus can ever be achieved, which restores the rights of having pure water back to every individual.
