To the Judgement Debtor Nicola Willis care of 138 Messines Road, Karori, Wellington 6012

A commercial lien was placed against Nicola Willis on 24 July 2024 where she was commissioned from that time to action the orders of Commander and Chief Janine of the House of Arabella and Walters over the Crown corporations through un rebutted lawful commercial judgement summary process. Nicola Willis had been provided the means to pay off the national debt and cancel the fraudulent debts placed over all the inhabitants and people of New Zealand. She chose not to and has continued actions of harm of making the people debt slaves through fraud and deceit. Due to acting in dishonour she became personally liable for the national debt and all debts of the Crown corporations she represents, plus any and all criminal charges associated with her actions.

The 17th day of December 2024 was the final day for payment. The payment due on the seventeenth of December in the year two thousand and twenty-four was **two hundred and forty-two quadrillion, seven hundred and seventy-one trillion, eight hundred and forty-four billion, eight hundred and ninety-six million, four hundred and eighty-five thousand dollars in numbers \$242,771,844,896,485,000.00 to be paid out in 0.9999 gold bullion in ten once bars**. This is the amount that was before the court on 9th day of December for payment by 17th day of December where the currency chosen is 0.9999 gold bullion in ten troy once bars to be delivered to the claimant's address care of 37 Glue Pot Road Oropi, Tauranga (3173).

Due to non payment a court hearing was held on the third day of January 2025, where Nicola Valentine Willis was made insolvent and this is her formal lawful bankruptcy notice where she is no longer able to hold positions of authority, and all shareholdings that she held as minister now allocated to the Assignor Janine of the Royal House of Walters. A civil and criminal court number have been allocated due to the seriousness of the charges where criminal charges will be laid if she does not action the following orders where the court has appointed Janine of the Royal House of Walters as the official assignee to whom Nicola Willis is ordered to make payment in full and provide a full written report with statement of financial affairs and full list of assets and liabilities, plus all the roles and shareholding financial records and operation information she is holding in her role as the Minister of Finance and Public Services and Social Investments and Climate Change and any other role that she acts on behalf of. The living woman Nicola Willis has until the seventeenth day of January in the year of two thousand and twenty-five to make payment in full in gold and submit a report back to the Assignor being the Crown Janine of the Royal House of Walters showing every register public and private and crown and admiralty plus any overseas register plus any other register that contains information regarding each of the Crown corporation's financial operations with personal and criminal liability for not providing this information.
