Judgement was obtained against Shane Reti in the private plus as minister of the Crown corporations on the nineteenth day of July in the year 2024 for making the inhabitants of New Zealand debt slaves, allowing harm to occur to the people through the fluoride going into the water plus allowing the ongoing roll out of the covid-19 vaccine when evidence provided of harm and high death rates and allowing harmful substances going into the air, land, water, food, animals, plus intentional revenue making off the people for civil matters and fines/charges where there is no evidence of harm plus involvement in removing the God given and inalienable rights of freedom of life security and liberty of every man, woman boy and girl living in this land plus allowing the people and land to be the security for the corporations own debt by fraud and deceit plus allowing energy corporations to make such high profit margin and double dipping payments off the people through fraud and deceit plus withholding the truth from the public and personal liability for the full debt owned by the crown corporations of two hundred and forty-two quadrillion, seven hundred and seventy-one trillion, eight hundred and forty-four billion, eight hundred and ninety-six million, four hundred and eighty-five thousand dollars in numbers \$242,771,844,896,485,000.00 plus lawful right to seize all financial and operational records, Intangibles, Negotiable Instruments, Investment Securities, All Present and After Acquired Property, Documents of Title, Chattel Paper, Money, precious metals and any owned Goods to the same value until paid out in full. The only remedy is for full pay out and to take responsibility to undo the harm that has been done to help prevent further deaths and poverty.

The 17th day of December 2024 was the final day for payment. The payment due on the seventeenth of December in the year two thousand and twenty-four was **two hundred and forty-two quadrillion, seven hundred and seventy-one trillion, eight hundred and forty-four billion, eight hundred and ninety-six million, four hundred and eighty-five thousand dollars in numbers \$242,771,844,896,485,000.00 to be paid out in 0.9999 gold bullion in ten once bars**. This is the amount that was before the court on 9th day of December for payment by 17th day of December where the currency chosen is 0.9999 gold bullion in ten troy once bars to be delivered to the claimant's address care of 37 Glue Pot Road Oropi, Tauranga (3173).

Due to non payment a court hearing was held on the third day of January 2025, where Shane Reti was made insolvent and this is his formal lawful bankruptcy notice where he is no longer able to hold positions of authority, and all shareholdings that he held as minister now allocated to the Assignor Janine of the Royal House of Walters. A civil and criminal court number have been allocated due to the seriousness of the charges where criminal charges will be laid if he does not action the following orders where the court has appointed Janine of the Royal House of Walters as the official assignee to whom Shane Reti is ordered to make payment in full and provide a full written report with statement of financial affairs and full list of assets and liabilities, plus all the roles and shareholding financial records and operation information he is holding in his portfolios as minister.

The living man Shane Reti has until the seventeenth day of January in the year of two thousand and twenty-five to make payment in full in gold and submit a report back to the Assignor being the Crown Janine of the Royal House of Walters showing every register public and private and crown and admiralty plus any overseas register plus any other register that contains information regarding each of the Crown corporation's financial operations with personal and criminal liability for not providing this information.
