**CREDITOR'S APPLICATION FOR ADJUDICATION ORDER**

To the Registrar of the High Court at Christchurch

This document notifies you that –

1. The creditor **Christine Glenda Russell** will on *Thursday 24 July 2025*  
*at 10am* ask the court to make orders –
  - (a) adjudicating **Brian Walter Gibbons** bankrupt; and
