**TAKE NOTICE** that I, Brian Walter of the bloodline of Gibbons have claimed back my full rights and property ownership over my life and affairs:

I, Brian Walter of the bloodline of Gibbons have corrected the record preserving all rights without prejudice that I am alive and well with dominion over my own affairs in accordance with my tabled unrebutted Affidavit of Status and Life LCA-BW-24091952-001, likewise my unrebutted claims on land of Substance and Trespass Notices CLS- BW-24091952-001, & CLS-BW-24091952-002, and my Personal Property Security Registrar.

I, Brian Walter of the bloodline of Gibbons further affirm my former Notice of Liability dated 1 July 2025 sent to you Amber Lee Orr (on behalf of MMC Law, and you in person; and also Christine Glenda Russell) have not been rebutted by you, nor Christine Glenda Russell, thus are by tacit acceptance now unrebutted and accepted as correct as tabled to you as stated; and thus now liable for all True Bill Ledger accounts in full, including my lodged and detailed High Court Affidavit of Response / Counterclaim Plaintiff Claims for loss of personal Income; and all work costs tabled (and lodged in the High Court Christchurch 8 May 2025) for works undertaken and completed to Christine Glenda Russell's Pukehina beachfront property whilst unable to undertake work in my normal capacity.

I, Brian Walter of the bloodline Gibbons further affirm my advice and confirmation to you Amber Lee Orr and Christine Glenda Russell that the District and High Courts were insolvent as of 10 June 2025, referencing "Public Notices NZ" and attaching (and sending you advice two times of this) links to this in respect of referencing same; albeit you Amber Lee Orr, Christine Glenda Russel, and others, including but not limited to; The Deputy Registrar of the Taupo District Court Leanne Bams; The Deputy Registrar of the High Court in Christchurch Sarah Danks; Associate Judge Lester of the Christchurch High Court; and Sanjai Raj (Registrar of NZ Companies Office) as named knowingly elected to ignore this and deceitfully undertook and perpetrated harm upon me in the full knowledge of this. All (as in one and all) are thus liable for the True Bill Ledger accounts resulting from actions as raised in accordance with my affidavit, and the Insolvency Court Hearing making all district and high court and family courts insolvent in New Zealand dated 10 June 2025.

As Public Notices NZ advises and confirms that all the judges and registrars in all of the high courts, district courts and family courts in operation in New Zealand were made insolvent in a court of law on the tenth day of June 2025 for intentionally taking control over living men and women using corporate law and trickery to make man crown property as a 'person' who is defined in section 13 of Legislation Act 2019 as 'person includes a corporation sole, a body corporate, and an unincorporated body' and none of these identities is a living man. This is an action of coercion with intent to deceive and harm through enslavement. It removes man's identity, ability to self-determine and take dominion over himself and the earth according to Genesis chapter one.

The judges and registrars have been also deceiving man and woman into joinder with a corporate fiction name that was set up to represent them with the purpose of gaining access to private ledgers of funds in unit trusts for every inhabitant on earth. The judges and registrars have also been using joinder to place debts on men and women and make them debt slaves, where fraud and deceit and slavery are crimes. This has caused significant harm to men and women plus they are seizing property using fraud and deceit.

As Leanne Bams (Deputy Registrar of the Taupo District Court), Sarah Danks (Deputy Registrar Christchurch High Court), and the presiding Associate Judge Lester, and Sanjai Raj (Registrar of Companies and Corporations, NZ Companies Office), Amber Lee Orr (Barrister), and Christine Glenda Russell have now acted in bad faith they have removed their immunity and are now liable in the private for charges of one million dollars per event and/or per day plus for the following crimes:

**A. Crimes Act 1961 (New Zealand) where 's' stands for section of the act**

- **s98** – *Dealing in slaves*: Treating a man or woman or their offspring as property.
- **s115,116** Conspiring to bring false accusation, conspiring to defeat justice
- **s174 & s175** – Threats and intimidation
- **s217–219** – Theft, including by deception and conversion
- **s227–228** – *Dishonestly taking or using property or documents.*
- **s230** – False accounting
- **s240–243** – *Obtaining by deception, causing loss by deception*: Relevant to the basis of false charges and seizures.
- **s258–260** – *False statements, conspiracy to defeat justice and defraud.*

**B. Mercantile Law Act 1880 / Bills of Exchange Acts (1883, 1908)**

- Fraudulent use of instruments or misrepresented financial claims as false justification for seizure or arrest.

**C. Cestui Que Vie Act 1666**

- Legal fiction of death used to deny living rights—facilitates seizures and deprivations without true jurisdiction or standing.

**D. Secret Commissions Act 1910 (Ch. 6–9, 13)**

- Undisclosed benefits to agents (e.g., police, government officers, or legal counsel) involved in facilitating the false arrest, charges, or seizures.

**E. Maritime Crimes Act (s4 & s6)**

- Jurisdictional overreach; treating a living man or woman as cargo or vessel.
- Seizure of personal property under commercial law without lawful contract or consent = piracy under color of law.

**F. Uniform Commercial Code (UCC)**

- UCC 1-308, UCC 1-207 – Reservation of rights.
- UCC 2-104 – Misapplication of commercial jurisdiction.
- UCC 1341, UCC 1342 – Mail/wire fraud and criminal use of legal instruments for personal or institutional gain.

**G. Common Law England / Imperial Laws Application Act 1988 – sect 5**

- Upholds right to property
- Recognizes bodily integrity, personal liberty, and justice as inalienable.
- Reservation of rights. Fraudulent use of instruments and processes to cause harm or pecuniary gain

**H. International Covenant on Civil and Political Rights (ICCPR):**

- Affirms rights to bodily autonomy, family life, and non-coerced consent.

**REMEDY**

Leanne Bams, Sarah Danks, Associate Judge Lester, Sanjai Raj, Amber Lee Orr, Christine Glenda Russell are guilty of the above crimes plus winding up of my private trust account where I am the only true heir and beneficiary; and all payout requires to be to me as the secured party creditor and true heir.

The remedy is that named individual parties have until 17 August 4pm to correct the injustices, publicly stating the removal and overturning of the corruptly fabricated and gazetted bankruptcy of my copyrighted legal fiction name being BRIAN WALTER GIBBONS, where a formal written apology from each party on publicnoticesnz.com dismissing the insolvency and stating that no further action will be taken, or I receive full payout of the wind up of my trust fund which is estimated in value of four billion US dollars delivered to my home address in ten troy ounce 0.9999 gold bullion bars.

TOTAL OUTSTANDING DEBT on 7<sup>th</sup> day of August 2025 against Associate Judge Lester, Leanne Bams, Sarah Danks, and Sanja Raj, Amber Lee Orr, and Christine Glenda Russell in the private comes to a total of four billion, two hundred and eighty four million, four hundred and sixty eight thousand and three hundred and thirty two US Dollars on the True Bill Ledger accounts in the named individuals to this date with ongoing True Bill Ledger penalties of ten percent weekly accruing interest, plus costs.

If no public apology in writing on publicnoticesnz.com and no payout of gold received to my address by 17 August 2025 then all individuals identified and named above become liable for the full debt owed to me of four billion, two hundred and eighty four million, four hundred and sixty eight thousand and three hundred and thirty two US dollars as clearly stated on the attached bill ledgers which will continue to go up ten percent penalty interest per week until settled in full. I also have the lawful right to liquidate each individual and the corporation or trust or entity they act on behalf of and seize their assets, plus have them prosecuted for their crimes under the Jurisdiction of God Almighty and the courts that are operating under this jurisdiction.
