**I. Recitals, whereas; -**

iii) All central banks, bullion banks, commercial banks, and clearinghouses currently in possession of the above-referenced assets.

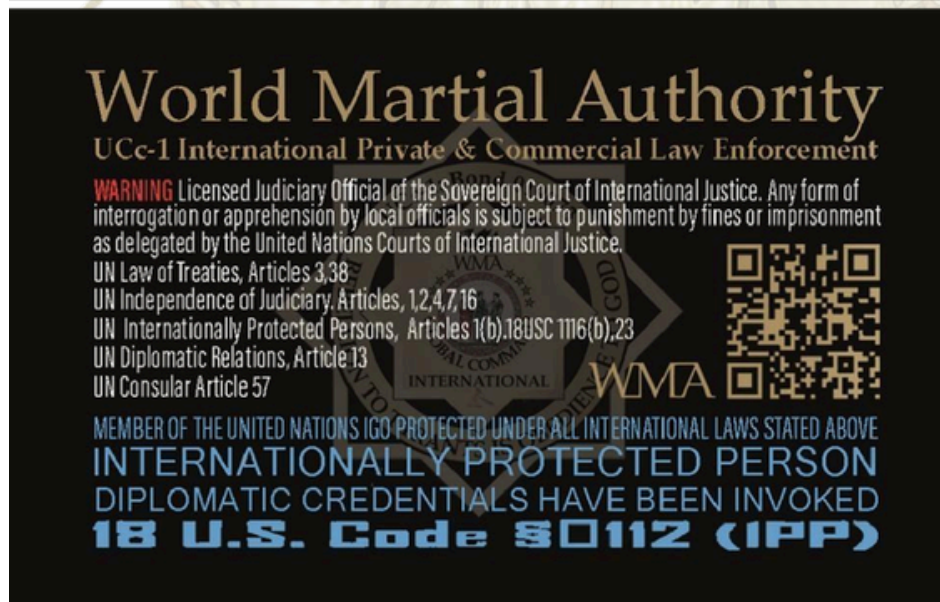
## II Appointment and Authority

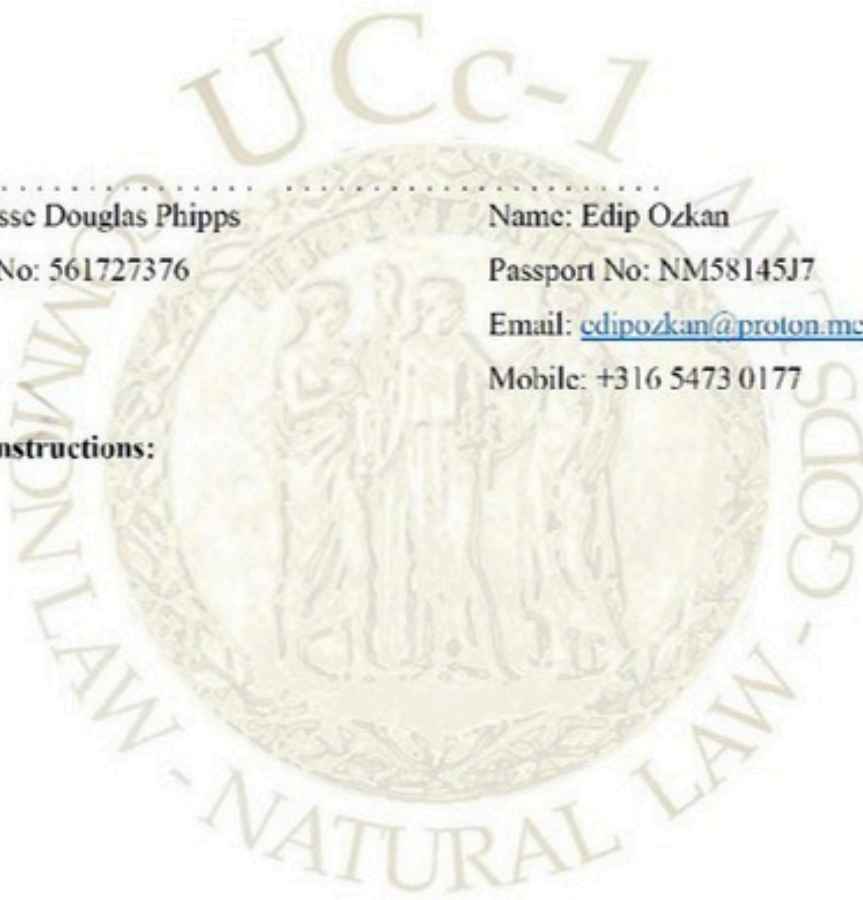

At a session of said Court, held in the Oakland County Probate Court, on this 17 day of December 2025.

PRESENT: Hon. Daniel A. Brien, Probate Judge

THIS MATTER having come before the Court on the Motion of the Co-Executors, **Alan Crummack** and **Harold R. Sullivan**, to compel Tier-1 financial institutions to recognize the Letters of Authority and open the required Estate Fiduciary and Receiver-Compatible Accounts; the Court having reviewed the pleadings, the Letters of Authority previously issued in this matter, the accompanying exhibits, and being fully advised in the premises:

**IT IS HEREBY ORDERED THAT:**

**1. Tier-1 Institutions Must Recognize Letters of Authority**

Any Tier-1 financial institution selected by the Co-Executors SHALL recognize and honor the Letters of Authority issued by this Court in Case No. 2025-426,787-DE.

**2. Required Accounts SHALL Be Opened and Activated**

Upon presentment of Letters of Authority, the institution SHALL immediately open and activate:

- a. Estate Fiduciary Checking Account
- b. Estate Fiduciary Savings Account
- c. Receiver-Compatible Estate Account, capable of receiving:

- On-ledger funds (M1)
- Off-ledger funds (M0)
- Credits convertible into currency
- Multi-currency transfers
- Transactions not requiring central bank pre-approval
- Transfers requiring institutional-level reserves
- International wire & SWIFT MT/MX traffic
- ISO 20022 compliant financial message transfers
- Historical instruments, historical bonds, and unrecorded lawful wealth as legally payable under applicable banking standards

These capabilities are commercially reasonable standard functions for Tier-1 global banks and are necessary for the lawful settlement and administration of the Estate.

---

### **3. Tier-1 Banks Are Prohibited from Refusing Based on Internal Policies**

No Tier-1 institution may refuse, obstruct, delay, or otherwise deny establishment of the required accounts based solely on internal policy, including but not limited to:

- State-of-death restrictions
- Geographic restrictions
- Internal estate-account risk limitations
- Non-statutory compliance preferences
- Internal operating rules

Internal policy cannot override Michigan EPIC law or a valid Letter of Authority.

---

### **4. Required Compliance with Applicable Constitutional, State, and International Financial Law**

Tier-1 institutions SHALL act in accordance with:

- The United States Constitution

- The Michigan Estates and Protected Individuals Code (EPIC)
- Applicable domestic banking law
- Applicable international financial-transfer law
- SWIFT and ISO 20022 standards
- Lawful foreign financial instruments and legally recognized obligations

This Order does not compel acceptance of *unlawful* transfers but compels acceptance of any **lawful** instruments or assets relevant to the Estate.

---

## 5. Obstruction of Estate Administration is Prohibited

Any refusal or delay by a Tier-1 bank that interferes with the Co-Executors' statutory duties under MCL 700.3705 or MCL 700.3711 SHALL constitute:

**a material obstruction of estate administration**

and SHALL authorize this Court to impose:

- Sanctions,
- Contempt findings,
- Mandatory compliance orders,
- Or any other remedies necessary to ensure proper administration of the Estate.

## 6. Deadline for Compliance

All Tier-1 institutions SHALL:

**Complete account establishment once the Letters of Authority are presented.**

after presenting required identification.

## 7. Further Relief

The Court reserves jurisdiction to enter **additional orders** required to effectuate estate administration or enforce compliance with this Order.
