Attached is the Directive, generated as a consequence of the Thames Coromandel District Council (TCDC) being served the Default Notice requesting they **correct misleading identities and errors** in their policies, application forms etc. This is relevant to all New Zealand Government, Parliament and the Crown agencies and agents

The QR code on the Directive will take you to the Affidavit, Notice to Cure, and Default Notice issued, received and un rebutted by TCDC. The named men and women within the affidavit have full responsibility to uphold the contents identified that are fraudulent and forbidden, leading to actions of dishonour and bad faith resulting from their malfeasance and to enact the remedy/Directive locally, regionally, nationally and internationally immediately

Every living breathing man, agents of the crown, parliament, government etc have the responsibility to enforce this Directive to correct the serious wrongs that have been identified that impact all of us

Conspiring or acting to obstruct, prevent, pervert to defeat this Directive, any false statements by any promoter, will be seen as a threat by their fellow living breathing man and dealt with as believed reasonably necessary to uphold peace and good order

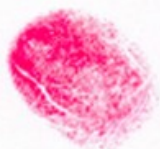
